		Putting People First in Public Housing Transformations To optimally serve the needs of residents, dramatic transformation is becoming more and more necessary as housing stock ages and becomes antiquated for the specific needs of the households served. Transforming these properties is not easy and impacts the lives of the people it is supposed to serve. Often the needs of the people are secondary to financial feasibility and political will. However, there is, and has to be a better way of handling these transformations and Putting People First. It is Vital and should be the focus of transformations through Choice Neighborhood, RAD, Section 18 Conversions, and other tools. The panel will discuss the successful approaches utilized to Put People First for RAD and Choice Neighborhood and other types of conversions including strategic planning, staffing needs assessments, resident case management, and relocation practices.

	Maricruz Difey, HACLA Andrea Garcia- Miller, HACLA Walter Finnigan, HACLA	PHA Fraud Investigations & Non-Compliance – Is This the Right Program for You? An overview of how HACLA investigators investigate allegations of fraud and non-compliance at PHAs. Information will be shared on evidence gathering, field interviews, inter-agency cooperation, and the lead-up investigation in preparation for the unlawful detainer process in public housing communities. Investigations involving Section 8 programs will also be discussed. We will explore opportunities given for resident compliance, which include verbal and written warnings and re-inspection; describe our collaboration at HACLA with the LAPD through the Community Safety Partnership (CSP) program as well as collaboration with HUD Office of Inspector General (OIG); a HACLA staff attorney will explain her insider's approach to the Unlawful Detainer (eviction) process in public housing. We will describe how we provide opportunities for resident compliance, which include counseling, warning letters, the grievance process, and curable notices. Finally, for those violations that are incurable, such as threats to the health and safety of the community, we will explain trial strategies for quick resolution.

HUD's Housing Counselor Certification Requirements

Are you required to comply with new certification regulations? In December of 2016, HUD published the Housing Counseling: New Certification Requirements final rule. This rule implements statutory requirements that housing counseling required under or provided in connection with all HUD programs must be provided by a HUD certified housing counselor beginning August 1, 2020. This means that any public housing authority (PHA) that offers housing counseling or runs a housing counseling program must be approved by HUD as a housing counseling agency, and all housing counselors must be certified by HUD. There are several public housing and voucher programs that are affected. Specifically, Housing Choice Voucher (HCV), Homeownership, and Family Self Sufficiency (FSS) administrators may be affected and should take note of this rule.
