Upper Moreland School District will collect activity fees to help fund the essential equipment and excess expenditures related to operating its co-curricular programs. Co-curricular programs include sports, Indoor Guard and Indoor Percussion. Activity Fee Funds will be collected by the District, and administered by the Activity Fee Committee as directed by the Upper Moreland School Board. Forms and online payments are due prior to the first scheduled practice. If the activity includes tryouts and "cuts", refunds will be provided to participants who are not selected for the activity. Listed below are the fees for the Winter activities. Please check the appropriate activity and make payment online (cash or checks will not be accepted). **PLEASE NOTE:** Indoor Percussion and Indoor Guard participants do **NOT** need a physical!!! Athletes who submitted their completed physicals for fall sports need only complete Section 8 ([Re-Certification by Parent/Guardian](#)) of the PIAA physical form which is available for download on our school district website.

Athletes will not be able to participate in tryouts unless this paperwork has been handed in **prior to 8:00 AM on Wednesday, November 10th**. Reminder to athletes – PIAA Physicals **must** be dated after June 1, 2020 (Indoor Percussion and Indoor Guard Activity does **NOT** require a physical). Athletes will not be eligible to participate in tryouts unless this paperwork has been handed in and processed. **PLEASE NOTE: There could be a 24 hour delay for paperwork to be processed.**

Refunds will be provided under the following circumstances: 1) The student suffers a season-ending injury prior to the mid-point of the season for which the Activity Fee has been paid. The injury must prevent the participant from engaging in half or more of the regularly scheduled contests and a medical authorization letter must accompany all such requests. 2) A student and their family move out of the district. Refunds will be prorated based on the number of regularly scheduled contests remaining when the student moves away. Students who quit an activity any time during the activity season are not eligible for a refund. Students who are removed from an activity for disciplinary reasons are not eligible for a refund.
