

LPGA AMATEUR GOLF ASSOCIATION
CHAPTER EVENT/LEAGUE WAIVER, RELEASE, AND INDEMNIFICATION AGREEMENT

The undersigned ("Player"), wishes to participate in the event or league _____ ("Event") being sponsored by the LPGA Amateur Golf Association–Chicago Metro Chapter ("Chapter") of the LPGA Amateur Golf Association ("LPGA Amateurs Program") and, as a condition of being permitted to do so, agrees to be bound by the following conditions, terms and release, whether the event is golf-related or social in nature.

ASSUMPTION OF RISK AND RESPONSIBILITY. Player understands that golf is a sport requiring physical exertion, and may involve other individuals, flying projectiles, motorized vehicles and other unknown, unanticipated or unpredicted risks and/or hazards, including exposure to SARS-COV-2 coronavirus that causes the COVID-19 virus ("COVID-19"), and that Player may be exposed to the risks of serious injury, permanent disability, or even death ("Event Injuries"). PLAYER IS FULLY AWARE OF, AND ASSUMES, THESE RISKS. PLAYER ACKNOWLEDGES AND RECOGNIZES THAT PLAYER'S PARTICIPATION IN THE EVENT IS VOLUNTARY AND UNDERTAKEN BY PLAYER AT PLAYER'S OWN CHOOSING AND WITH A FULL UNDERSTANDING AND AWARENESS OF THE RISKS THAT IT POSES TO PLAYER AND TO OTHERS.

Player understands that the Chapter may or may not provide the Player with any assistance, guidance or training in the sport or the rules of the game and/or golf course being played, but that the Chapter providing such (or not doing so) in no way affects, alters or modifies the terms Player is agreeing to herein.

Player recognizes that the Chapter cannot control the conditions of the golf course; nor control the conduct of other individuals playing at the golf course or employees/staff on the golf course, or any other individuals (including other Event Players) or uninvited guests; nor otherwise reduce any risk to which Player may be subject during any time period Player is playing golf.

Player also certifies that Player is in adequate physical condition and fully capable of playing the game and undertaking any tasks that Player chooses to perform.

AGREEMENT REGARDING COVID. WITHOUT LIMITING THE FOREGOING, PLAYER ACKNOWLEDGES THE CONTAGIOUS AND HARMFUL NATURE OF COVID-19 AND KNOWINGLY AND VOLUNTARILY ASSUMES THE RISK THAT PLAYER MAY BE EXPOSED TO OR INFECTED BY COVID-19 BY PARTICIPATING IN THE EVENT. Player agrees that Player will be subject to frequent temperature checks and verbal and/or written questionnaires and will be expected to practice social distancing and good personal hygiene, including wearing masks if mandated, at all time ("Prevention Measures").

Player attests to have read and will abide by the CDC's recommendations regarding the prevention and the spread of COVID-19 at: <https://www.cdc.gov/coronavirus/2019-ncov/prepare/prevention.html> and that if Player's community has a shelter in place order, that Player will not participate in the Event during the duration of a shelter in place order.

Player certifies that, to Player's knowledge, Player is not now infected with COVID-19, is not experiencing symptoms that may be associated with COVID-19, and in the past 14 days has not been in close contact with anyone infected with COVID-19. Player will inform Chapter leaders immediately if any part of these certifications ceases to be true during the Event. Player further agrees that failure to submit to any Prevention Measures shall be cause for refusing and/or removing a Player from taking part in the Event at the sole discretion of Chapter leaders.

Release of Claims. PLAYER ASSUMES ALL RISK AND DANGER SURROUNDING AND ASSOCIATED WITH PLAYER'S PARTICIPATION IN ACTIVITIES AND EVENTS ORGANIZED AND SPONSORED BY THE CHAPTER, from known, unknown, obvious and hidden conditions, including, without limitation, all Event Injuries, being struck by misdirected golf balls or carts, falls on and/or around the Event golf course and surrounding areas, and actions of third parties, whether such risk or danger occurs prior to, during, or subsequent thereto. In consideration for allowing Player to participate as a Player and all other benefits to Player arising therefrom, Player, Player's personal representatives and administrators, heirs, and next of kin hereby waive, release, covenant not to sue, and forever discharge the Event, Chapter, The LPGA Foundation (the "Foundation"), LPGA Amateurs Program, Ladies Professional Golf Association ("LPGA"), the host facility and golf club, all sponsors and/or third parties involved in the Event, and each of their respective affiliates, officers, directors, employees, volunteers, sponsors, workers, members and agents (collectively, "Releasees") from and against any and all injuries, losses, damages, claims, actions, and any liability of any kind (including, without limitation, personal injury, death, or loss or damage to personal, private, or other property) ("Claims"), whether caused by the

negligence of Releasees or otherwise, as a result of or in connection with Player's participation in and/or presence at the Event. Player further agrees to indemnify, defend and hold harmless the Releasees for any liability, demand, judgment, claim or suit, including reasonable costs and attorney fees, arising out of or in connection with Player's acts or omissions or allegations thereof as a Player in the Event and/or while Player is on the Event property. Player will be responsible for Player's personal belongings and equipment and will not hold Releasees responsible for their loss. Player will treat the facilities and equipment provided in connection with the Event with care and Player understands Player will be assessed for any damage to facilities or equipment caused by Player's acts or omissions.

Agreement to Follow Rules, Policies and Procedures. Player acknowledges that Chapter may implement and enforce rules, policies and procedures in connection with the Event, including without limitation to ensure appropriate conduct by participants and to implement and comply with public health and safety requirements, guidelines and/or recommendations, whether relating to the COVID-19 virus or otherwise (collectively "Event Rules").

Player agrees to comply with all such Event Rules and agrees that if Player fails to comply with any Event Rules or commit any misconduct, or if Player's participation might pose any health risk to others, all as determined by the Chapter in its sole discretion, Chapter may refuse to allow Player to participate in the Event, without any refund to Player or any liability to Chapter.

First Aid. In the event that Player is unable to do so on Player's own because of injury or illness, Player consents to administration of first aid and/or medical treatment, and agrees to indemnify, waive, release, covenant not to sue, and forever discharge Releasees from any and all liability or claims arising out of such treatment.

Miscellaneous. Player acknowledges that the terms of this document may be modified at any time to impose new or additional terms or conditions related to participation in the Event. Such modifications and additional terms and conditions will be effective immediately and Player's continued participation in Event will be deemed acceptance thereof. Player agrees that Florida law shall govern any and all disputes arising in connection with participation in the Event, receipt of services described in connection therewith, and disputes involving Releasees. Such disputes shall be resolved by arbitration in the State of Florida pursuant to the Commercial Rules of the American Arbitration Association then in force. A judgment upon the award rendered by the arbitrators shall be final and non-appealable and may be entered in any court having jurisdiction thereof.

Program Diversity/Core Values Statement. The LPGA Amateurs Program is an inclusive organization that strives for membership with full participation, regardless of race, gender, age, national origin, sexual orientation, career choice or golf ability. The LPGA Amateurs Program believes that the practice of valuing and celebrating diversity will strengthen the status of women and that it is vital to our organization's vision and mission. Further, the LPGA Amateurs Program operates under a set of Core Values that guide the expected conduct of all associated with the LPGA Amateurs Program and all Players are expected to and agree to adhere and comply with these policies and procedures. Player affirms that Player has read and understands this Chapter Event Waiver, Release and Indemnification Agreement, and that Player has executed this document freely and voluntarily, and entirely upon Player's own initiative, and intends to assume all risk and responsibility for Player's actions and further agrees to sign the same willingly and accept its terms and conditions.

Media Rights/Likeness. Player hereby grants permission throughout the universe in perpetuity to the LPGA Amateurs Program, its employees, agents and assignees to capture at or in connection with Events and utilize Member's likeness image, voice, and/or words (collectively, Likeness") incidental to any pictures, television, radio, videotapes, recordings, film, the Internet, or any other form or medium now known or hereinafter devised (the result of which are, together with all rights therein, the "Recordings") without compensation, payment of royalties, notification, or permission. Player further understands and irrevocably agrees that (i) these Recordings will become the property of the LPGA Amateurs Program and will not be returned to Player; (ii) the LPGA Amateurs Program may edit, alter, copy, exhibit, publish or distribute Recordings for purposes of publicizing or promoting the LPGA Amateur Golf Association, the Foundation, LPGA, or their programs, or for any other lawful purpose; and (iii) Player waives any right to inspect or approve the Recordings or use of Player's Likeness.
