- This application must be accompanied by the \$175 registration fee. You will be notified if your application is not accepted, and your registration fee will be returned. The registration fee is **non-refundable** once your child is enrolled.
- Midway UMC members have first priority until January 21. Current students/siblings have second priority until January 28. Registration is open to the public beginning February 2.
- Registration forms and payment must be dropped off at the preschool office at the address above.
- September – May tuition is due by the 1st of each month. A \$20 late fee will be assessed for tuition received after the 10th.
- A \$60 Activity Fee will be billed and paid in October of each year.
- One month (30-day) written notice is required prior to withdrawal. If not provided to Preschool Director, family is responsible for tuition billed.
- Midway Preschool is exempt from licensing through Bright from the Start Georgia Department of Early Care and Learning. Midway Preschool has complied with all criteria and requirements for this exemption.
