# **Accelerating Innovation**

**Success in convalescent plasma therapy** - AdventHealth has had success with convalescent plasma therapy for COVID-19, treating more than 50 patients, and has quickly become one of the top hospitals in the nation for this treatment. **Convalescent Plasma** means taking donations of plasma from patients who've recovered from COVID-19, and transfusing the is plasma into patients who are still fighting the disease. Antibodies in the plasma have the potential to help these patients recover.

**AdventHealth launches first-of-its-kind immunotherapy treatment**: AdventHealth physicians are the first in the world to launch a pioneering treatment targeting certain blood cancers for patients who have exhausted all other types of therapy.

The first patient to receive this therapy was treated in late April at AdventHealth Orlando and is recovering at home. He will be monitored to determine the efficacy of the treatment, which may take several months. More details can be found here.
