## New Year, New Deadlines

As 2020 comes to a close, we are already busy developing projects and preparing grant applications for the upcoming 2021 grant cycles. While each project is unique, and every funding agency has their own guidelines and requirements, certain information is mandatory for nearly all applications. In recent years, it has become crucial for cities and counties to maintain a current registration in Sam.gov. This is a requirement for all Federal Programs. More and more programs are requiring online submittals either through Grants.gov or another federal portal. Some state programs are now requiring online submittals as well.

Occasionally grant funds are made available due to federal disasters or other special circumstances, we've seen this a lot over the past 9 months during the COVID-19 Pandemic, but generally the projects funded in our area are through regular grant programs with annual funding cycles.

Here are some of the grant programs and deadlines that we are already working on for 2021.

AHPP County Courthouse Restoration (January 29, 2021)-Grants available for restoration projects at historic courthouse across the state.

AHPP Historic Preservation Restoration Grant (March 5, 2021)-Grants of \$10,000 or more are available for restoration projects at properties listed on the National Register of Historic Places and owned by a not-for-profit organization or a municipality.

AEDC Division of Rural Services Rural Community Development Grant and Rural Fire Protection Grant (March 11, 2021)-Applicants from incorporated towns of less than 3,000 in population and

unincorporated rural areas are eligible for up to \$15,000 in 50/50 matching funds under this program.

AEDC General Assistance and CDBG-CV (CARES Act) Projects (March 31, 2021)-The community population must be at least 51% Low to Moderate income. Grant awards are between \$75,000 and \$300,000

ArDOT Transportation Alternatives Program and Recreational Trails Program (TBD)- The TAP provides funding for programs and projects defined as transportation alternatives, replacing the funding from per-MAP-21 programs. The Recreational Trails program is funded through a portion of TAP funds set aside specifically for recreational trails.

AEDC Division of Rural Services Rural Block Grant Program (August 2021)- Grants are available to incorporated towns and rural communities with a population of less than 3,000. Additionally, the community population must be at least 51% Low to Moderate income.

Outdoor Recreation Grant Program 50/50 Matching Grant (August 27, 2021)-Grants awarded up to \$250,000 for a total project cost of \$500,000. This is a reimbursable grant program. This means that the grantee must finance 100% of the cost of the project, and then be reimbursed for half of the amount of the project cost up to the grant amount.

Outdoor Recreation Grant Program FUN Park Grant (August 27, 2021)- Each grant award is \$75,000. Only unincorporated rural communities and incorporated cities with a population of less than 2,500, as established by the 2010 census, are eligible for grant funding.


## EMPLOYEE SPOTLIGHT
