Dear Jabula Constituent:

Grace and Peace!

Some would say that these are turbulent times while others would share these to be exciting times. No matter what school of thought you lean toward we can all agree that God holds time in His hands, and we trust Him to see us through every season that we will experience.

We are coming into a season of newness concerning specific areas within Jabula. With Bishop Hugh D. Smith leading the way we are pressing forward into these exciting times with great joy and courage. His leadership is greatly dependent upon having the team properly aligned and prepared. An aspect of readiness and preparation is having our core leaders licensed and informed of the direction we are taking as an organization. We are aware that many of you have not renewed your license in the previous two years due to the global pandemic. However, we see that much of the world is reopening slowly, but progressively. We want to help address that matter as effectively and efficiently as possible.

In my new position of International COO, I have been in numerous conversations with our International Director of Licensing, Pastor Yvonne Brooks about the systems and protocols being employed within the licensing department. We realize that many individuals are not fully aware of the proper channels to utilize to be licensed and to renew one's license. This will not be the case going forward.

A few new elements have been added, a few adjustments have been enacted concerning licensing that we want to inform you of. Please continue to read entire letter that we may hereafter be in synch – one with another concerning licensing:

1. All Five-Fold Ministry personnel must be licensed within Jabula.
2. All licenses granted are granted by the endorsement of the Senior Pastor or Regional Bishop. Once extended the license is due for renewal every three (3) year cycle.



1. All renewals require that a **Letter of Standing** be signed and submitted by the Senior Pastor to the Licensing Department via mail or email.
2. Payment should be remitted by money order or online via the Jabula website (jabulaworldwide.com)
3. See the Senior Pastor or Church Licensing Liaison for amount for renewal at each ministry level.
4. Once both payment and the Letter of Standing are received, the Licensing Staff will forward the new license to the address of record.
5. Every church is expected to appoint a Licensing Liaison who will work as the intermediary with the Licensing Department and the church.

It is our desire to close this gap regarding the many persons whose licenses have expired or are about to expire due to no fault of their own. Therefore, please see your Senior Pastor for the applicable renew rates for your ministry level. Let me say once again that we are excited about the days ahead. We see tremendous opportunity to reach the nations, but we need everyone to be on board, committed and prepared. Licensing is one element of that preparation.
