April 2025 ECOEA Retired News Brief by District Representative Kathleen Purdy

Government Pension Offset/Windfall Elimination Provision

GPO/WEP repeal is now law (Social Security Fairness Act) in the remaining 11 states that were affected. The average retroactive payment is around \$6,000. Many members began receiving their checks on or around March 18. This accounted for 1/3 of the first batch to be received. One Californian reported receiving \$44,000. Republicans have raised questions about the solvency of the Social Security Trust fund. A proposal to force all new state and local employees into Social Security has also been squashed.

Social Security Administration DOGE staff cuts have led to increased call times, and initial claims are taking longer than before. Conservatives would like to privatize the system. **Frank Bisignano**, nominee for Social Security Administrator has fired over 57,000 staff. NEA opposes his nomination.

The GOP Reconciliation Bill includes tax cuts for billionaires. It requires 51 votes (50 if the Vice President is a member of the majority party), not 60 as is usually the case. Reconciliation cannot be used to cut Title I, special education, or Social Security. It includes \$330 billion in cuts over ten years: school meals, student aid and loans in higher education, Medicaid, and CHIP.

The GOP voucher bill gives a dollar-for-dollar return for giving to private and parochial schools and helps the rich evade taxes.
