**Clerk's Report:** Year-to-date the church membership is 724. Attendance in December 2015 was 1354 and 1892 in December 2016.

### **Financial Report:**

- \$10,000 donated without any restrictions
- Combined Budget giving increased from 18% to 22% of the amount of tithe
- Church budget giving - \$227,124
- Evangelism giving -\$25,238
- Building Fund giving - \$61,912

God richly blessed our church this past year and we met our church budget goals plus we had \$10,000 donated without any restrictions. A motion was made to accept the financial report plus put the \$10,000 donated into the new building fund.

### **Cradle Roll SS Leaders:**

Two people have agreed to serve as Cradle Roll leaders—Nicole Warren and Aubrey Nelson. Nicole is not now a member but her transfer is in progress. A motion was made to accept these two people to serve in this capacity.

### **Building Addition:**

During the December Business Meeting, an Ad Hoc committee was appointed to come up with recommendations on where to locate the addition to the church. The following two recommendations were brought to the meeting:

- a. To further explore architectural plans to expand on the North East (NE) side in order to make a fully informed decision.
- b. That a collaborative Master Plan be developed that includes present and future needs for HMS Richards School, Campion Academy and Campion SDA Church.

This committee talked to around 100 people at Campion Church, Campion Academy, and HMS School. The Ad Hoc Committee recommends that we have the architect draw some plans for the north side so we can make a fully informed decision. After a lot of discussion, the following two motions were made:

- a. A motion was made that we accept recommendation (a) with the following addition--having the plans ready by the February 27 business meeting.

- b. A motion was made that we recommend (b) to Campion Academy and HMS School for them to consider.
