**Approval of Minutes for March:** A motion was made that the minutes be accepted as written.

**Clerk's Report:** The membership YTD is 728. There were eleven transfers to Campion Church, two baptisms, and five transfers out and one death. Attendance in April 2016 was 1794 and 1686 in April 2017. The following are transfers in this month:

### **Finance Committee Report:**

YTD giving of \$74,438.33 compared to April 2016 at \$56,377.75.

At the end of April 2017, our combined budget is \$2,121.67 behind our goal. By comparison, last year it was \$14,747.81 behind our goal. The building fund now has \$152,736.86 (account 4055) plus \$5,76.59 (account 4080). **Voted and Approved**

Finance Committee recommended the allocation of \$2,100 from account #2900 for the Hallway/Narthex Lighting

Finance Committee recommended we move away from PushPay now that Adventist Giving has updated their platform and allows for recurring giving. Mobile app services will be provided by Subsplash with a monthly fee of \$140.

### **Major Improvements Update:**

#### **Lighting:**

**Carpet:** A motion was made that we ask Finance to find the funds to carpet not only what the insurance company approved as a result to the flood damage in the hallway and up the stairs, but also the three classrooms on the north side of the Church. Total funds needed: \$20,500.

**Capital Campaign Update:**

Jill Anderson challenged us to think in terms of a “stretch commitment”.

- As of this date, we have a cash commitment from Church Board Members of \$254,000. Not all Board Members have yet reported their personal commitment. As of this date we have 85% of the Board Members who have responded on what they are willing to give sacrificially and generously.
