JOB DESCRIPTION:

CAMP COUNSELORS - Full and Part Time Positions (CSW III, \$16.54-20.10/hr.)

- Plans, organizes, and directs camp and summer programs and activities at the direction of the Head Counselor.
- Supervises children ensuring safety and positive behavior.
- Ability to communicate courteously and effectively.

HEAD CAMP COUNSELORS – Full and Part Time Positions (CSW IV, \$17.36-21.11/hr.)

- Applicants should have at least three years of experience leading groups of children. Teachers, paraprofessionals, and coaches are encouraged to apply.
- Responsible for day-to-day operation of summer camp and summer programs and activities at specific site.
- May supervise subordinate staff.
- Maintains records and submits reports.
- Oversees safety and behavior of youth; making onsite appropriate decisions.
- Ability to communicate courteously and effectively;

CAMP COORDINATORS – Full Time Positions (CSW V, \$18.23-22.16/hr.)

- Applicants must have completed two years of college and have at least three years of experience leading groups of children. Current and former teachers are encouraged to apply.
- Oversees several summer camp locations including supervision of subordinate staff.
- Responsible for ensuring the safety and security of youth participants and promoting positive behavior.
- Responsible for implementation of NCC rules, regulations, policies, procedures, and programming.
- Serves as primary liaison between programs and Program Manager.
- Works independently and make appropriate decisions.
- Helps to investigate and resolve complaints and inquiries.
