2020 election vital to personal rights

One of SVARW's favorite speakers, Brad Dacus, Founder and President of Pacific Justice Institute, returns to set the stage for the importance of the 2020 election for religious freedom, the U.S. Supreme Court and parents' rights.

Pacific Justice Institute is a non-profit 501(c)(3) legal defense organization specializing in the defense of religious freedom, parental rights, and other civil liberties. Pacific Justice Institute works diligently, without charge, to provide its clients with all the legal support they need.

Brad Dacus served as a legislative assistant to former Sen. Phil Gramm (R-Texas), and went on to receive his law degree from the University of Texas. Brad coordinated religious freedom and parental rights cases throughout the western United States for five years prior to founding Pacific Justice Institute in 1997. The institute has a network with hundreds of volunteer affiliate attorneys and handles more cases on the west coast than any other organization of its kind.

Brad Dacus can be heard weekly on The Dacus Report on more than 170 radio stations across the country and also as a guest speaker on numerous radio and television programs across the nation. He has appeared on America Live, CBS Evening News, CNN, Dateline NBC, Good Morning America, MSNBC, NBC News, News Talk TV, and The Today Show and numerous times on FOX News.

Mr. Dacus' varied public speaking opportunities include public debate

and testifying before the U.S. House of Representatives. He has also testified numerous times before the California State

Legislature on legislation affecting religious freedom and parents' rights. Mr. Dacus continues to speak regularly at churches, conferences, graduations and

conventions throughout the United States and was presented an honorary Doctorate of Religious Freedom and Family Rights degree from California Baptist University in recognition of his commitment to faith and justice and his work protecting parental rights and religious freedom through the Pacific Justice Institute.

Free book at January meeting is great educational tool

The first 200 attendees at our January SVARW meeting will be offered a free copy of "The Little Book of Liberal Lies" by Elbert Guillory, a powerful book that gives Republicans an effective tool to re-educate brainwashed minds that have suffered for more than 60 years in California under undue influence from Democrats and their programming media. Those interested in ordering additional copies can do so from Elbert Guillory's America, P.O. Box 160, Lawtell, LA 70550, 1-337-942-6328. The cost is \$2 per book to help his office cover expenses.

Using short texts and photos, African-American Elbert Guillory puts his message across, derailing three Democrat lies:

- All Republicans are racist.
- Democrats are champions of civil liberties.
- The Democrats' agenda is best for black Americans.

Guillory's primary interest is in encouraging black Americans to get off the Democrat plantation and get involved in politics. But his book speaks to all of us. His work helps all races and ethnicities rebuke Democrat lies and propaganda, helping us all learn what it means to be a Republican.

For those who plan to give this book to others, a word of caution: It may be important to follow up and discuss it. Guillory's book is most effective if

read in entirety. Some may say they will read it but when asked about it later, they may confess they only read the first few pages. The problem is, people have been heavily indoctrinated at school, in their social group(s), and by the media in general. Many of our nation's younger generation are invested financially in a job. If their boss is a Democrat, they may fear losing their job if they dare express their own opinion. Today's technology is so pervasive that it threatens workers. So, expect some may be too afraid to accept the education. The hope is those who do take the time to read this book will learn what it means to be free.

Guillory reminds us what the differences are between Democrat and Republican. He shows us that being a Republican is much more than believing in smaller government and less taxes. As a former member of the Louisiana State Senate (2006 to 2016), as a Christian, a mountain-climber by avocation, and having served in the U.S. Navy in Vietnam, attorney Elbert Guillory at age 75 draws an analogy of racist Democrats in empty suits like plantation owners disguising control over everything as charity while doing this using other people's money. Slavery, he writes, still exists in the form of welfare and food stamps. Guillory shows us that the Democrat Party's agenda is an illusion. It takes away the power, rights, and

responsibilities from the individual. At the heart of liberalism is the belief that only a great and all powerful central government can be the benefactor of social justice for all Americans. Where once Americans relied on their family, church, and community, Democrats focus on control.

Elbert Guillory's biography is presented on-line in Wikipedia. In 2013 as a Louisiana State Senator, Guillory switched from being a Democrat to being a Republican, calling Democrats "the Party of Jim Crow." The Republican party, he said, is "the party of freedom and progress," comparing himself to abolitionist Frederick Douglass, a Republican who had supported Abraham Lincoln.

Read Elbert Guillory's "Little Book of Liberal Lies." It is an educational building block that will help freedom-loving Californians fight to restore a Republican form of government in California.
