RE: Consultation Regarding Recovery Actions for Southern Resident Killer Whales

I am writing to follow-up on the correspondence you received Friday, April 12, 2019 with respect to consultation regarding recovery actions for Southern Resident Killer Whales (SRKW). In addition to the information webinar on Thursday, April 18, Fisheries and Oceans Canada (DFO), Transport Canada (TC) and Environment and Climate Change Canada (ECCC) are launching a website, as well as holding three community meetings on April 23, 24 and 25, 2019. Both the website and the public meetings are intended to provide additional opportunities for the public, stakeholders and communities to provide input and feedback on potential SRKW recovery measures for 2019.
