Export Navigator

Export Navigator is a community-based program that provides free support and ongoing guidance to help B.C. businesses expand beyond local markets.

Who is eligible: All businesses located in B.C. are eligible to join the Export Navigator program.

BC Manufacturing Jobs Fund (BCMjf)

BCMjf helps manufacturing companies modernize, innovate, and grow by providing funding for capital projects in all regions in B.C., particularly in communities affected by economic impacts or downturns.

Note: The BCMjf intake is currently closed as of November 15, 2024.

Who is eligible: Businesses, for-profit organizations, entities with for-profit manufacturing operations, including First Nations and Indigenous- and First Nation-owned enterprises.

ESG Centre of Excellence

The Environmental, Social and Governance (ESG) Centre of Excellence is a support hub that provides ESG guidance, resources, and tools for B.C. businesses, organizations and entrepreneurs. The Centre offers advisory services to help businesses build capacity and equip them to meet ESG demand.

Forestry Innovation Investment (FII)

FII supports a wide variety of organizations under the Market Initiatives program that work towards our common goal of advancing B.C.'s forest sector with a direct benefit to B.C. forestry and value-added wood product manufacturing exporters.

Who is eligible: Groups representing multi-company interests, academic and research institutions, First Nations councils and non-profits, government entities, and more.

The BC Agriculture and Food Export Program (BCAFe)

Funded under the Sustainable Canadian Agricultural Partnership (Sustainable CAP), the BCAFe provides cost-share funding to eligible sector business and associations to undertake market development activities outside of B.C. The program aims to increase sales, reduce market risk, and enhance long-term sustainability for B.C.'s agriculture, food and beverage exporters, enabling them to maintain, expand and/or diversify export markets.

Who is eligible: Eligible applicants include agriculture producers with a head office in B.C.

InnovateBC Integrated Marketplace Initiative

The Integrated Marketplace (IM), developed by the Province of B.C. under the StrongerBC Economic Plan and supported by PacifiCan, accelerates the adoption of domestic innovations to advance decarbonization, competitiveness, and safety. Delivered by Innovate BC in partnership with Testbeds, IM helps domestic companies secure key reference customers, driving scale-up, export growth, and job creation.

Who is eligible: Eligible companies operating within the three approved testbeds may submit a project proposal to the IM program upon agreeing to IM's program conditions.

CleanBC for Business

CleanBC offers programs and incentives to help B.C. businesses green their operations and grow new business opportunities through innovation:

- The CleanBC Industry Fund can leverage investments to lower emissions and improve operations
- B.C.'s Forest Carbon Initiative improves the use of residual wood and forest fibre, and promotes sustainable forestry
- CleanBC Plastics Action Fund reduces plastics and makes better use or recycled plastic in manufacturing processes
- B.C. Centre for Innovation and Clean Energy supports B.C. innovators scale clean energy solutions for global impact
- CleanBC Building Innovation Fund supports new low carbon building solutions
- CleanBC Go Electric Advanced Research and Commercialization programs

Who is eligible: B.C. resident producers who have a track record in the domestic film and television industry; B.C. resident producers who have been pre-selected to attend a particular market site; B.C. residents who have experience producing domestically owned and controlled digital media content.
