## **OptumServe Sites in Lower Lake, Lakeport Offering FREE COVID-19 Vaccine and Testing** *Appointments Encouraged, Walk-Ins Accommodated as Capacity Allows*

*COVID-19 Vaccine Also Now Available at Walmart in Clearlake*

**Lake County, CA (April 29, 2021)** — Starting next week (Monday, 5/3), OptumServe's sites in Lakeport and Lower Lake will be open Monday-Friday.

Here is the schedule of no-cost services that will be offered:

- **Lakeport** (10am-7pm, Silveira Community Center, 500 N. Main St) – COVID-19 Vaccine Mondays and Fridays; COVID-19 Testing Tuesdays, Wednesdays, Thursdays
- **Lower Lake** (7am-7pm, Lower Lake Town Hall, 16195 Main St.) – Vaccine Tuesdays, Wednesdays and Fridays; Testing Mondays and Thursdays

Appointments are preferred for both vaccination and testing, but walk-ins will be accommodated, as capacity allows. This is a great opportunity for some people that have been unavailable to access Drive-Thru clinics due to work conflicts to get vaccinated.

Both first and second dose COVID-19 vaccination appointments can be scheduled at <https://MyTurn.ca.gov>. All currently available OptumServe appointments offer the Moderna vaccine. You can schedule your second Moderna dose at an OptumServe site, even if you received your first dose at a Drive-Thru site or another clinic.
