

**NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.**

1. **PROMOTION DESCRIPTION:** The Downtown Committee's Delicious Deals Stamp Card Promotion ("Promotion") begins on February 1, 2021 at 8:00 a.m. and ends on February 28, 2021 at 11:59 p.m. (the "Promotion Period"). The presenter of the Promotion is the Downtown Committee (the "Presenter"). By participating in the Promotion, each Entrant unconditionally accepts and agrees to comply with and abide by these terms, conditions, and rules (collectively, the "Official Rules") and the decisions of Presenter, which shall be final and binding in all respects. Entrants should look solely to Presenter with any questions, comments or problems related to the Promotion. 2. **ELIGIBILITY:** Open to legal residents of the continental United States who are 18 years of age or older except as specifically excluded as set forth herein. Final eligibility for the award of any prize is subject to eligibility requirements and verification as set forth herein and in paragraphs 2, 5 and 6 hereof (an "Eligible Entrant"). Option 2: Entrants may pick up a Delicious Downtown Deals Stamp Card ("Stamp Card") from any participating business and purchase "Downtown Deals" from participating restaurants to earn a sticker to be placed on the Stamp Card. Securing seven (7) stamps earns Entrant one (1) entry in the drawing, securing 14 stamps earns the Entrant two (2) entries in the drawing, and securing 21 stamps earns three (3) entries in the drawing. Entrants may submit photos of their submission to [mail@DowntownSyracuse.com](mailto:mail@DowntownSyracuse.com) by the end of the Promotion Period (**February 28, 2021 at 11:59 p.m.**) in order to participate. Presenter's database clock will be the official and sole timekeeper for the Stamp Card submission. Entrants are responsible for the accuracy of all information contained within their submitted email (the "*Entry Information*").

The contents of the email submission and decision to disqualify an Entrant is final and made solely in the discretion of the Presenter.

5. **WINNER SELECTION:** All Entrants at the close of the Promotion Period will be entered into a drawing (the "*Prize Eligible Entrants*") to win a prize (the "*Prize*"). The winner of each prize being made available will be selected in a random drawing from among all Prize Eligible Entrants. A minimum of ten (10) winners will be selected in a random drawing from among all Prize Eligible Entrants. Each of the foregoing drawings will be conducted after the Promotion Period on March 3, 2021 starting at 1:00 p.m. at the Presenter's offices by Presenter and/or its designated representatives, whose decisions are final.
