He founded Prairie Plant Systems Inc., the sole provider of legal medical cannabis products to Health Canada from 2000 to 2013; led the company and CanniMed Ltd. as the first recipients of licenses to produce medical cannabis, took CanniMed public in 2016, which received industry attention and was acquired by Aurora Cannabis Inc. in March 2018 for CAD \$1.2 billion.

Shortly thereafter, in his hometown of Saskatoon, Brent founded ZYUS Life Sciences Inc., a globally focused biopharmaceutical company that offers patients cannabinoid and other phyto-therapeutic medical solutions. In 2014, Mr. Zettl was awarded the Ernst and Young Entrepreneur of the Year Award for the Prairies Business-to-Consumer category.
