LSB FALL SEMESTER UPDATES

Below are some of the projects the Lukenda School of Business has been working on this fall:



Prof. Mindy McCready attended the ACBSP Region 4 Conference on October 19 and 20 in Minneapolis, MN. The theme of the conference was “Transforming Student Success through Recruitment, Retention and Reentry”. Professor McCready delivered a presentation entitled, “The Lukenda School of Business’ Occupational Education Day”.

Dr. Madan Saluja attended the Academy of Business Research Conference in Las Vegas, NV from September 30 to October 4. He also attended the 2017 Ferris State University Construction Hall of Fame Induction honoring former LSSU Trustee and alumnus Gary Benjamin. Mr. Benjamin recently retired as CEO of Gundloch Champion, Inc. of Iron Mountain, MI.



Prof. Marta Diaz attended the Lilly Conference in Traverse City, MI on October 19-21. The Lilly Conference focused on evidence-based teaching and learning. Some of the sessions included: examining delivery methods for math-based business courses, teaching online: a survivor’s guide, teaching in the hybrid classroom: collaboration and competition, and examining successful faculty learning communities. The sessions also highlighted several research projects from various disciplines that focused on teaching techniques for different delivery methods and included the use of technology in the traditional classroom.

Prof. Jody Rebek presented at the Leadership Conference 2017 in Victoria, BC to professionals and academics from the West Coast. This workshop communicated current and future research in mindful leader development. Academics and leaders of organizations discussed implications for learning and integration of mindfulness within organizational operations/offers. Prof. Rebek will also be conducting a leadership course (Mindfulness leader development research) at LSSU in the 2018 spring semester, and it is open to all students. Participants of the course will be invited to participate in leader development research to help identify strength-based practices for learning important leadership skills.



The Graymont Community Development Fund, administered by LSSU, issued a total of \$95,000 in grants for the 2017 grant cycle. The committee made seven awards from a field of 17 applications. Entities and projects receiving grant awards were: Michigan Karst Conservancy, Engadine Consolidated Schools, West Mackinaw Health Association, Trout Lake Township, Hendricks Township, Feneley McNeil Nesbit American Legion Post 290 and Hudson Township. The fund was established to address community development opportunities for local municipalities, schools, and other entities located in the Eastern Upper Peninsula. The Community Development Fund is administered by Eric Becks, Associate Dean of the College of Professional Studies & Outreach and Director of Intellectual Property and Economic Development at LSSU.

Heidi Berg, Director of the LSSU Escanaba Regional Center, was involved in a local professional development group that met monthly called Delta Force. In October, the group “graduated”, earning certificates of completion and she was selected as the commencement speaker. She gave her speech at the 2017 Delta County Chamber of Commerce Annual Awards Dinner.
