Vendor must be present for the duration of show: Starting Window is 4:00 to 6:00 p.m. Breakdown at 9:30.

- Booths must be set up without disruption to foot traffic or other exhibitors.
- The day of show, vendors are greeted and shown your booth location. There is a north and south gate entrance. Set-up and start time, is available from 4:00 to 6:00pm. (In consideration of vendors coming from other day markets). Market is open until 9:30. No early breakdown.
- No vehicles are allowed in show areas where pedestrians are walking the venue. An early breakdown disrupts the other exhibitors and the flow of foot traffic. Other than an emergency, if this occurs, you will be ineligible to exhibit at future shows. Everything must be carted off property until 9:30 pm.
- All workspace and artist belongings, including chairs, must be contained within the assigned booth space. **Exhibitors are required to use sufficient weights to secure tents. No Weights - No Set-Up.** Vendors will keep their area clean during and after the show. This includes trash removal.
- Each vendor is responsible for collecting and reporting Florida sales tax on all sales made during markets.
