

**“ New 3G All- Weather Rugby Facility fund raising up and running**

**October 2023 Update**

A project to install a 3G All-Weather Rugby facility in the College has commenced and to date **€481,701** in donations have been received from Past Pupils with strong support coming from LC Classes 1971 – 1980 and good support from LC Classes 1956 -1960 and 1981-1985. We'd really like to see all years on the graph below. The new facility is for the use of boys and girls in Rockwell and will be completed to the highest standards as laid down by World Rugby. It is a facility that Rockwell need to ensure the students can train and compete at the highest level in schools' rugby and safeguard the long standing tradition of rugby in the College. The facility will also be available for use for other sports at the discretion of the College Principal.

The estimated costs for the project is **€800,000 - €650,000** for the pitch construction and covering, fencing, goal posts, dug-outs and pathway for machinery and players access to the pitch, and **€150,000** for floodlights which are to a “night time game & training” standard.

We are approaching the project in two phases with the pitch Phase 1 and floodlights Phase 2.

The Principal, Board of Management and Trustees have given their approval for the project subject to all funds being lodged with Rockwell prior to any work commencing on site.

**We need YOUR SUPPORT NOW to raise €170,000 so we can complete Phase 1.**

The minimum donation that allows Rockwell claim tax relief is €250 and whilst **all donations are very welcome**, big or small, we hope that some Past Pupils will donate larger sums to enable us progress with this project as soon as possible. **Please SUPPORT YOUR ALMA MATER.**

**My donation is on the basis that the development of the pitch is intended to support the provision of rugby primarily at Rockwell College and to enhance the provision of sports in general. To that end, boys and girls rugby will have priority of use, as the layout and design of the pitch will be for that purpose. PE class groups will also have regular access as is the case with the current all weather hockey and 5 a-side soccer pitches at Rockwell College. Use by all**

other sports and teams will be at the discretion of the College Principal, notwithstanding the need to protect the facility for the purpose for which it is designed and installed. As the facility is intended to be for the use of Rockwell College students, any hire to external groups will be permitted only at the discretion of the College Principal. In the event, for any reason, the all-weather pitch is not completed or well advanced by 31/12/2024, Rockwell College agree to refund contributions made to all Donors.


