- Income at less than 185% of Federal Poverty Level (\$42,606 for 3 people)
- Impacted by COVID-19 (loss of income, housing instability)
- Resident of Sonoma County



Frequently Asked Questions

How do I calculate my income to see if I qualify?

Eligibility for this program is a gross household income (before taxes) of 185% or less of the federal poverty line.

What does it mean to be "impacted by COVID"

- "I lost my job because of COVID-19"
- "I lost some or all of my income (missed work, no child care available, caring for someone with COVID) because of COVID-19"
- "I have been evicted or lost my housing because of COVID-19"

If I am selected to receive the money, do I have to participate in research interviews?

IF you CHOOSE, you can participate in surveys and interviews if you do, you will get an extra stipend for your time (in addition to the monthly \$500).

Will it affect my public benefits?

Cash will be received monthly, some of your public benefits could be impacted by these cash payments. Households are encouraged to apply and if selected, will have access to a calculator at enrollment to see estimated impact on public benefits Selected households will be provided with helpful documentation to show eligibility workers

What happens after I apply?

If you are one of the selected households, you will be notified via a text or email that you provided during the application. You will be asked to submit documentation verifying your eligibility, only if you are selected for participation. Once all required verification is submitted and approved, you will choose your payment method and start receiving payments in January 2023.

If I am selected, how will I receive the money?

You can choose to receive the \$500 monthly via a prepaid debit card, a direct deposit into a bank account, via PayPal, or via Venmo.

The application period is September 1, 2022 through October 31, 2022.
