Poison Control offers this advice for household products...

How can I store and use household products safely?

- **Store cleaning products safely:** Store food and non-food products separately in your home. Keep the original label on the container intact. Use child-resistant containers whenever possible and be sure they are closed properly. Learn more tips by visiting nyc.gov/health and searching for poison proof your home.
- **Use cleaning products safely:** When used correctly, bleach and other cleaning products are helpful to prevent the spread of germs. Only use one cleaning product at a time. Mixing cleaning products, such as ammonia and bleach, creates a poisonous gas. Open a window whenever possible to make sure there is air flow.
- **Be careful with hand sanitizer:** Hand sanitizer may be difficult to find in the store right now. Making home hand sanitizer is not recommended because, if not made properly, it may not be effective in infection control and prevention. In addition, improperly-made hand sanitizer can cause damage to your skin. Ingestion of any alcohol-based hand sanitizer and excessive topical use of hand sanitizer, especially for children, can also be dangerous. Typical use of topical hand sanitizer on hands alone should be fine.

Besides household products, medications are also a big risk for unintentional poisonings amongst children. The New York State Medication Training program has these tips to offer when it comes to medications...

- Store all medication safely.
- Medication needs to be kept in an area out of children's reach and sight.
- Keep all medication in its original labeled container.
- Use childproof containers whenever possible.
- Never leave medication unattended.
- Always return medication to the storage area immediately after use.
- Never call medicine "candy."
- Keep important phone numbers, such as the Poison Control Hotline, on or near your telephone.
- Always follow the Five Rights when giving medication to children.

If you suspect a child has accidentally taken medication or other poison, call the Poison Control number immediately. Do not wait for the child to look or feel sick.

When you call the Poison Control Hotline be prepared to provide the following information:

- Your name and the name of the person poisoned
- The telephone number you are calling from
- The age and weight of the person poisoned
- The name and amount of the product or substance involved
- How long ago the poisoning happened
- Any symptoms the poisoned person is having
