- ❖ **Get Help!** A team of insurance specialists from the Arkansas Insurance Department Seniors' Health Insurance Information Program (SHIIP) team will be present to work with you individually to help you compare coverage plans and rates for Medicare Part D (prescription drug), Supplemental plans (also called Medigap), and Advantage plans or Part C plans.
- ❖ **RSVP!** Please call the Jewish Federation of Arkansas at 501-663-3571 to let us know if you intend to come! Note: If you would like to come but cannot attend in person, please let us know and we will schedule a private phone consultation for you with a specialist from the Arkansas Insurance Department Seniors' Health Insurance Information Program (SHIIP) team.
- ❖ **Bring!** Bring your Medicare card and a list of prescription medicines including quantities and dosages. Tip: Bring your prescription bottles in a brown bag.

Should I attend?

Yes, if you or a family member...

- ... will be age 65 or older in 2016, or under 65 and have received Social Security Disability benefits for at least 24 months
- ... have, or want information about, Medicare Part A, Part B (Medical) and/or Part D (Prescription Drug Plan)
- ... have, or want information about, a Medicare Supplement Plan (also called Medigap) like Blue Cross Blue Shield, Health Advantage, AARP, Humana, QualChoice, United Health Care, etc.
- ... have, or want information about, a Medicare Part C Plan (also called Medicare Advantage)
- ... have Medicare *with* Medicaid and want to be sure your prescriptions are covered on your Part D plan
- ... would like to know if you qualify for help with the costs of Medicare
- ... receive retirement health coverage from the VA or your company, e.g. AT&T, Tricare, etc. and would like to explore other options
