1) The morning "Introduction to Scent work" session 8:30 to 12:30

Scent and Nose Work are sports that involve having a dog trained to find a specific target odor which is hidden in various environments and venues. This allows dogs the opportunity to use their strongest natural sense in a way that's fun, engaging, and that builds and strengthens a foundation of trust between the handler and dog. The Intro session will explain how the odor imprinting and search process works and includes demonstrations of the basic skills that dog/handler teams need to learn to begin in the sport.

Seminar is open to all levels. Working slots will practice specific aspects of imprinting and assessing and building hunt drive for the Target Odor Birch

2) The afternoon "Handler Discrimination" session 1:00 to 5:00

Handler discrimination or HD is unique to AKC Scent Work. Unlike the Odor Elements, which uses essential oils, HD uses an article (Cotton sock, glove, or cotton ball) scented with their handler's personal odor. The session will cover both the technique to use to imprint your scent on the article as well as how the training differs between HD training and training for essential oils. Since there is considerable cross-over in the imprinting and search techniques in HD and Tracking or Article Search trainers in other disciplines could find the session informative.

This session is open to all levels from just beginning to fine tuning skills at the Master level. Working slots will practice specific aspects of imprinting and assessing and building hunt drive for the Handler's own odor and discriminating between two individuals odors.

3) The Sunday "Advanced Scent work" session 8:00 to 5:00

The Advanced Scent team should have experience in at least one of the Scent and Nose Work Sports. The Advanced team dog has been imprinted on a target odor or odors, have competed (mock or full trials) and are seeking to understand how to work

with their canine partner more effectively, build their dog's working independence and boost the joy and ensuing rewards.

Working slots will practice imprinting on new odors, assessing and building hunt drive, scent theory and building dependable and discernable indication and alert behaviors.

Instructor Bio: Jennifer Anderson

Jennifer is a 2006 certified canine search specialist with the State of Rhode Island Search and Rescue Team task forces and member of the Rhode Island Canine Search and Rescue team (RICSAR), a Canine SAR team. Jen is an Urban Rubble, Cadaver and Wilderness Instructor with the International Police Work Dog Association (IPWDA); National Search and Rescue Association (NASAR) Tracker I, SARTECH II.

Her public/private training programs through her business River Horse K9 Training includes: AKC CGC and UGC and Star Puppy, Tracking /trailing, AKC Scent Work, ATT and Farm Dog Judge; scent discrimination and nose work craft, Scent Theory, AKC Fit Dog, K9 Core Fitness work and Obedience.

Jen employs a diverse cross section of animal and human educational skillsets crafting unique training programs to focus on each team's individual chemistry, physical needs of the desired training task and the building blocks of skills needed to reach an objective.
