

MHEC Contracts - March Addenda

A01 Appliances, Air Conditioners, Food Service Equipment & Laundry Equipment, Supplies and Services

- Effective April 1st, 2021, Automatic Laundry has been removed from contract due to lack of member utilization.

B14 Athletics: Gym & Field - Cardio & Strength, Games, Equipment, Uniforms, Supplies & Serv.

- Effective 4/1/2021, PlayPower Lt Farmington DBA Little Tikes Commercial has been removed from contract due to lack of member utilization.
- Effective 4/1/2021, New England Fitness Distributors, Inc. has been removed from contract due to lack of utilization of contract.

C04 Windows, Window Treatments, Specialized Curtains, Noise Reduction Products, Service & Supplies

- Effective April 1, 2021 Window Service Inc. has implemented a six (6) percent surcharge on balances (parts). This surcharge will be reviewed quarterly.
