Chevron July-September 2025 Recap

Quarterly results and financial snapshot

 Q2 2025 reported earnings: \$2.5 billion; adjusted earnings \$3.1 billion; Chevron returned \$5.5 billion to shareholders in the quarter and reported record production including 1.0 million BOE/day in the Permian Basin. July — major acquisition activity

· Completed acquisition of Hess Corporation (closing announced mid-July), creating a larger integrated oil & gas company and adding material assets including Guyana and Bakken positions.

August — operational performance and integration

· Operational highlights: Chevron reported continued strong execution and record company production and emphasized the strategic benefits of the Hess assets for extending production and free-cash-flow growth into the next decade.

September — integration costs, restructuring and commentary

- Transaction closing details and integration moves: Chevron's July closing of the Hess deal led to corporate governance and structural changes as Hess became a Chevron subsidiary.
- · Short-term earnings and capex impact: Chevron signaled it expected a third-quarter hit related to the Hess deal of roughly \$200-\$400 million, and increased near-term capital spending tied to newly acquired assets.
