The Mid Jersey Association of REALTORS® Good Neighbor Award will be presented to one REALTOR® who has made an extraordinary commitment to improving the quality of life in their local and/or global communities through volunteer work benefiting a 501(c)3 nonprofit charitable organization.

1. Nominees must be members of Mid Jersey Association of REALTORS® (MJAR) in good standing.
2. Nominees should have made a significant contribution of personal time, but contributions of money, materials, or other resources will also be considered.
3. The nominee's community work must have been conducted, started, or completed between August 2023 to the present.
4. Mid Jersey Association of REALTORS® will donate \$500 to the recipient's 501(c)3 organization.
5. All entries will be evaluated by a Mid Jersey Association of REALTORS® Committee.
6. The award recognizes individual contributions, not association- or company-wide efforts. However, if an individual within the company can be singled out as instrumental to the success of a group effort, he or she is eligible.
7. Nominees should be able to document the results of their involvement through published reports and/or testimonials from the organization they served or the people they helped.
8. Nominations must be accompanied by a completed entry form to be considered (REALTORS® may nominate themselves or may be nominated by another MJAR member).
9. Information provided on the application is subject to verification.
10. The Award Recipient will be announced in September 2024.
