



Missouri Chapter of the American College of Healthcare Executives (MO-ACHE) 2017 Annual Report

In 2017 the MO-ACHE Board of Directors (BofD) fulfilled its fiduciary responsibilities with 6 regular meetings with a quorum. This is a summary of activities which was presented at the 2017 Annual Meeting on November 2.

- The **corporate name** was changed to more closely align with ACHE national. This required a filing with the State of Missouri; chapter bylaws revision; approval by Deborah Bowen, ACHE President; and rebranding of documents including logo, etc.
- The 2017 ACHE **dues rebate** of \$19,456.50 was the highest ever received by the chapter. MO-ACHE is in a solid positive operating position with more than \$50,000 cash on hand. Year end 2017 financial statements will be shared after production in January 2018.
- The multi-year **Strategic Plan** was approved by the BofD and ACHE.
- The **MO-ACHE Leadership Plan** is a “living document” that was approved by ACHE
- There was continued good relationship with the Missouri ACHE Regent during transition from Janet K. Weckenborg, FACHE to Katherine (Katie) L. Nowak, FACHE. The **Regent's Advisory Council** (RAC) is now comprised of the BofD. This has allowed further interrelationship between the Regent and MO-ACHE committees, notably Membership and Communications. The chapter approved \$2,000 of non-budgeted expense to help finance the 8 required ACHE Higher Education Network (HEN) visits.
- The **Sponsorship Committee** has done an outstanding job of relating with new sponsors Mercy at the Platinum Level (\$15,000) and Allscripts at the Bronze Level (\$3,000) and soliciting new ones.
- The **Membership Committee** has developed 4 active teams: Best Practices, Recruitment, Retention, and Advancement. Great work has been done to build the teams and collaborate with the 5 Local Program Councils (LPCs) and Regent.
- The **Nominating Committee** developed a slate for BofD approval and member election.
- The chapter became an approved Missouri State Board of Nursing Home Administrators (**BNHA**) **Training Agency**. ACHE's support of the full continuum of care was also shown by chapter partnering with **Leading Age Missouri** for its first Annual Summit.
- Positive relationship with the **Missouri Hospital Association (MHA)** continues with renewed chapter exhibit at the 2017 MHA Annual Convention and Trade Show and Spring & Fall education programs offered in Kansas City and St. Louis.
- The **Communications Committee** has timely published the chapter quarterly newsletter, *MO-ACHE Chapter News* and numerous e-blasts. The 4th Annual MO-ACHE Student Essay Award (M-SEA) review panel has selected a talented future healthcare leader, St. Louis University student, **Andrew F. Oberle, Jr.**
- The **Local Program Councils** statewide presented 18 hours of ACHE Face to Face credit education programs to help fulfill the MO-ACHE Mission:
“to advance our members and healthcare leadership excellence”.
