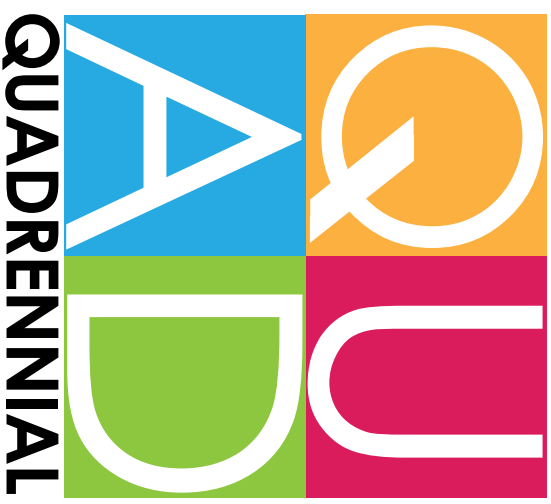




WHAT DOES QUADRENNIAL MEAN TO YOU?

REALTORS® are required to complete ethics training of not less than 2 hours, 30 minutes of instructional time within four-year cycles. The training must meet specific learning objectives and criteria established by the National Association of REALTORS® (NAR). The current four-year cycle will end December 31, 2016, meaning you must have completed your approved ethics class before the end of this year. Check your quadrennial status at LasVegasRealtor.com.

Training can be completed in the classroom through GIVAR or online through NAR. Completion of any of the following upcoming classes will meet the 2016 quadrennial requirement.
