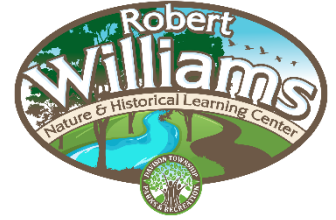

Applications will be processed on a first come, first served basis. Chairs, tables, and tents will **not** be provided - you may bring your own to decorate your space. **Spaces are a minimum of 10' X 10'.**

Bunny Trail Egg Hunt is from 11:00AM – 1:30PM on 4/16/22. Vendors may begin setting up at **9:00AM** the day of the Bunny Trail Egg Hunt. We ask that you be ready by **10:30AM** and stay until the last participant has passed your station at approximately **2:00PM**. Vendors **must** have at least one adult present and make sure their booth is manned at all times.

Decorations and/or mascot costumes are encouraged, but not required, and **must** be kid friendly.

Each Bunny Trail Egg Hunt vendor is responsible for providing **1000 store bought, individually wrapped, prepackaged items and/or coupon stuffed eggs** for their booth. You may purchase your own eggs or contact DTPR to pick up eggs to stuff. (We have thousands of eggs shells you may utilize for this event).
