Hartford HealthCare EMS Symposium

In-Person Attendee Coronavirus Policy

Following the guidance outlined by the state of Connecticut and health officials with Hartford HealthCare, the following guidelines will be in place for in-person attendees:

- 1) Upon entering the facility, all in – person attendees will
 - a. Have their temperature taken
 - b. Be asked screening questions related to signs and symptoms of the coronavirus
 - c. Be asked about travel policies
- 2) Attendees with a temperature of 99.9 or greater than temporal will not be allowed in the building.
- 3) Attendees answering yes to having any of the signs and symptoms of the coronavirus, or have been tested positive for COVID in the past 21 days will not be allowed in the building and advised to seek proper medical attention.
- 4) Attendees that have traveled to a state listed by the state of Connecticut as a “hot spot” for more than 24 hours within 14 days of the event will not be allowed to attend (and should be in a self-quarantined location).
- 5) While on property of Hartford Hospital and within the buildings of Hartford Hospital and the Center for Education, Simulation and Innovation, attendees are expected to:
 - a. *Wear a mask or face covering while in session or inside the building.*
 - b. *Maintain appropriate social distancing.*
 - c. *Not congregate in large groups in hallway areas.*

These policies are subject to change based on the current public health guidance and expectations set forth by CT DPH and Hartford HealthCare.
