House Leadership Announces 2021-2022 Committees

House leadership today announced its committee structure for the upcoming legislative session along with leadership and membership for those committees.

The structure will include two new committees:

- Water, which will be tasked with refocusing on the state's water issues, particularly in relation to our ag and rural economies. It replaces the Rural Revitalization Committee, which was temporarily enacted last term to provide a roadmap for the House on rural issues.
- Redistricting, which will begin laying the groundwork for the state's 2022 redistricting process.

"The new committees continue to reflect our priorities, which include protecting our state's agricultural roots for the long haul and ensuring a fair and equal voice for Kansans in every district," said Speaker of the House Ron Ryckman (R-Olathe).

Ryckman said committee assignments also continued to utilize the legislative and real-world experience of representatives throughout the state.

"This team of committee leaders brings a wide range of experience from the business, ag and healthcare sectors to the table. We're also confident this team of leaders will stick together when it matters most, which is critical to moving our economy forward," said Ryckman.

"Our committee leadership is unified in wanting to improve the economic outlook for all Kansans and help small businesses recover from the Governor's shutdown," said Ryckman. "That includes property tax transparency, giving Kansans a voice on the Value Them Both Amendment, adequate liability protections for business owners and healthcare providers, and positioning our state economy to recover more quickly instead of lagging behind what we're seeing in other states."
