Dear Parent or Guardian:

Vision To Learn is excited to announce that we will come to your child's school to provide vision services to students. This includes a routine vision exam and, if needed, eyeglasses.

All this is available at no cost to you.

About Vision To Learn

Vision To Learn is a non-profit organization working in communities across the U.S. offering vision services to students in support of their academic achievement.

Student Vision Services

Vision screenings will take place at your student's school. If your child does not pass the screening, they will be referred to the Vision To Learn mobile clinic to receive a routine eye exam by a trained and licensed independent optometrist. If needed, your child may also be prescribed glasses. The optometrist may also identify and refer students in need of follow-up vision care. *Eye exams do not involve eye drops or dilation.*

Vision To Learn follows CDC, state and federal regulations including staff daily health screenings, the use of Personal Protective Equipment for staff and students, non-contact exam procedures, enhanced ventilation on clinic, and thorough disinfection between patients. Vision To Learn is committed to following best practices to prioritize the safety of our students.

Student Information for Vision Services

The school will share your child's name, date of birth, gender, parent/guardian name, demographic and contact information, and vision screening results with Vision To Learn. Vision To Learn will share your child's eye exam information with the school. Vision To Learn may also share limited information required to receive programmatic funding from the state.

Medi-Cal Benefit Usage

Receiving vision services provided by Vision To Learn's mobile clinic will constitute a routine eye examination and – as needed – eyeglasses and dispensing of glasses that may be billed to your child's Medi-Cal benefits, if applicable. Please note that a no-cost eye exam and eyeglasses will be provided even if your insurance cannot be billed. You may receive a notice called an Explanation of Benefits (EOB) from your insurance carrier with information regarding the services billed and the payments that have been approved, but you will not receive any bill for the services or eyeglasses.

Glasses

If your child receives a prescription for glasses:

- 1) They will choose a frame
- 2) Vision To Learn will order the glasses
- 3) A trained and licensed optician will dispense glasses at the school within three weeks

Return this form if you do not want your child to receive free vision services.

If you choose to **opt out** of (or decline) vision services for your student, please complete the information below and return to your child's school by **in the next 3-5 business days**. If we do not receive a signed copy of this form, your child will receive the services.

Vision To Learn es una organización sin fines de lucro que trabaja en comunidades de los EE. UU. ofreciendo servicios de la visión a los estudiantes en apoyo de su desempeño académico.

Servicios de la visión para estudiantes

Se llevarán a cabo exámenes de la vista en la escuela de su estudiante. Si su hijo no pasa el examen, será referido a la clínica móvil de Vision To Learn para recibir un examen ocular de rutina de un optometrista independiente con licencia. Si es necesario, también se le pueden recetar lentes a su hijo. El optometrista también puede identificar y referir estudiantes que necesiten atención oftalmológica de seguimiento. *Los exámenes oculares no involucran gotas para los ojos ni dilatación.*

Vision To Learn sigue las regulaciones de los CDC, estatales y federales, incluidas las revisiones de salud diarias al personal, el uso de equipo de protección personal para el personal y los estudiantes y desinfección minuciosa entre pacientes. Vision To Learn se compromete a seguir las mejores prácticas para priorizar la seguridad de nuestros estudiantes.

Información del estudiante para los servicios de la visión

La escuela compartirá el nombre, la fecha de nacimiento, el género, los nombres de los padres/tutor, la información demográfica y de contacto y los resultados de los exámenes de la vista de su hijo con Vision to Learn. Vision To Learn compartirá la información del examen ocular de su hijo con la escuela. Vision To Learn también puede compartir la información limitada requerida para recibir financiación programática del estado.

Uso de los beneficios de Medicaid

NOTICE OF PRIVACY PRACTICES -- VISION TO LEARN

THIS NOTICE DESCRIBES HOW MEDICAL INFORMATION ABOUT YOU MAY BE USED AND DISCLOSED AND HOW YOU CAN GET ACCESS TO THIS INFORMATION. PLEASE REVIEW IT CAREFULLY. As Legal representative/parent of a minor patient, when reading this notice, please understand that the term "you" represents the minor patient. Vision To Learn ("VTL") provides optometric services to you and in doing so, may act as a Covered Entity for the purposes of compliance with the Health Insurance Portability and Accountability Act ("HIPAA"). VTL, its employees, and workforce members who are involved in providing and coordinating health care are all bound to follow the terms of this Notice of Privacy Practices ("Notice").

The most common way VTL will use your information is for treatment, payment, and health care operations.

- Treatment. Your PHI may be used and disclosed to provide treatment and other services to you—for example, to discuss and treat your injury or illness or condition with other providers.
- Payment. Your PHI may be used and disclosed to obtain payment for services provided to you—for example, disclosures to claim and obtain payment from your health insurer. We may send a bill to you or to a third-party payer, such as a health insurer.
- Health Care Operations. Your PHI may be used and disclosed for health care operations. For example, PHI may be used to evaluate the quality of optometrists. In addition, PHI may be shared with business associates who perform treatment, payment, and health care operations services on behalf of VTL.

For certain information, you can tell us your choices about what we share. If you are not able to tell us your preference because you are unconscious, we may go ahead and share your information if we believe it is in your best interest. We may also share when needed to lessen a serious and imminent threat to health and safety. If you have a clear preference for how we share in the situations noted below, please tell us.

- Share information with your family, close friends, or others involved in payment.
- Share information in a disaster relief situation.
- Contact you for fundraising efforts.
- We will never market or sell your personal information.

We are allowed or required to share your PHI in ways that contribute to the public good, such as public health and research. We have to meet many conditions in the law before we can share your information for these purposes. www.hhs.gov/ocr/privacy/hipaa/understanding/consumers/index.html

- Help with public safety issues such as preventing disease or reporting abuse
- Health research
- Comply with the law
- Respond to organ and tissue donation requests and work with a medical examiner or funeral

- Appeal a Medicaid decision

Our Responsibilities

- We will let you know promptly if a breach occurs that may have compromised the privacy or security of your information.
- We must follow the duties and privacy practices described in this notice and give you a copy of it.
- We will not use or share your information other than as described here unless you tell us we can in writing. If you tell us we can, you may change your mind at any time. Let us know in writing if you change your mind. For more information see:

Your Rights

- You can ask us not to use or share certain health information for treatment, payment, or our operations, but we are not required to agree to your request, and we may say “no” if it would affect your care.
- You have the right to ask to see or get a copy of your health and claims records and other health information within 30 days of the request. Contact Dr. Amanda Hikin at amanda@visiontolearn.org to obtain a copy of your records.
- You have the right to ask us to correct your health claims and records. We may say no but we must tell you why in writing within 60 days.
- You can request confidential communication or for us to contact you in a specific way.
- You can ask us for a list of the times we shared your health information withing the prior 6 years, one per year for free.
- You can ask for a paper copy of this notice at any time.
- You can choose someone to act for you and to make choices about your health information.

Changes to the Terms of This Notice

We can change the terms of this notice, and the changes will apply to all information we have about you. The new notice will be available upon request, on our web site, and we will mail a copy to you.

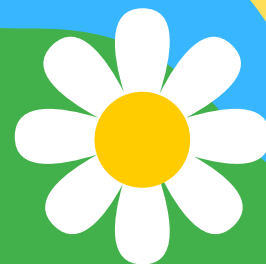

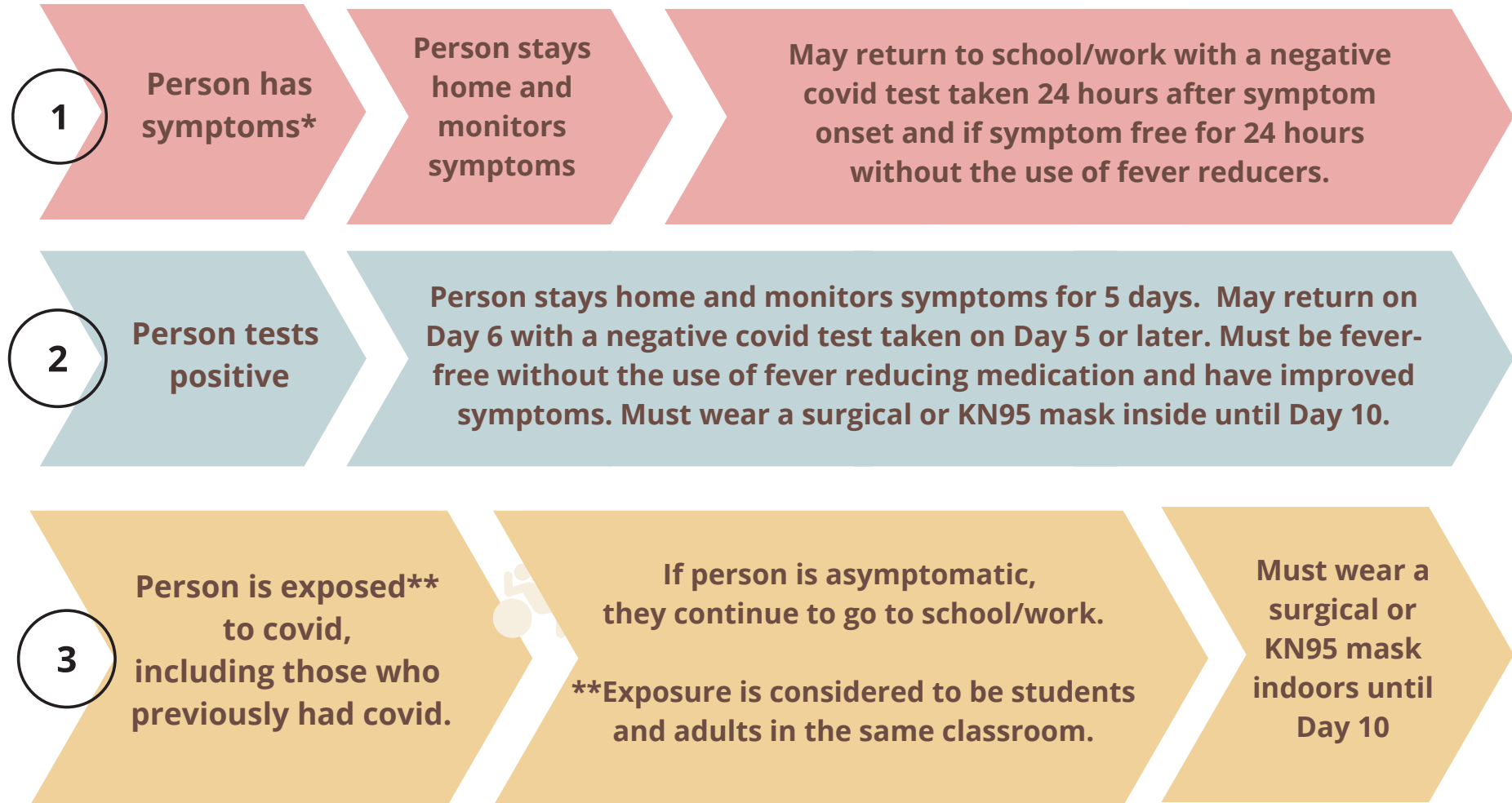

What is Family Promise?

Family Promise is an alliance of Christian churches that supports children and their families in the San Gabriel Valley experiencing homelessness. Many services are provided such as locating temporary and permanent housing, finding jobs, child care, and other services to assist families.

How does St. Philip support Family Promise and what is a host week?

St. Philip will host families currently in Family Promise for one week twice a calendar year. During our host week, the families will come to St. Philip every evening for dinner, sleep overnight at the St. Philip Parish center, have breakfast each morning, and pack a lunch as they leave for the day all while interacting with St. Philip parishioners. We will work with Family Promise and each family to ensure they feel welcome and cared for during our host week. The families will leave at the end of our host week for another local church.

How are families selected for the Family Promise Program?

Families accepted into the Family Promise program must apply, undergo a background check, and interview with the Family Promise Case Manager.

Where will the families stay during our host week and what hours will they be on campus?

Families will arrive at St. Philip each evening around 6 pm. They will be on the Parish Center's second floor and will depart each morning around 7 am. St. Philip volunteers will be at the Parish Center with the families the entire time.

How can I get involved?

We are building a brand new ministry to serve Family Promise so we need your help! Volunteers can fill many roles such as dropping off dinner, staying overnight in the Parish Center, interacting with the children in the evenings, and donating supplies such as air mattresses, bed sets, and more!
