#### **UW COMMUNITY IMPACT SUCCESS STORY**

This story from CASA's Executive Director Julia Livingston is another example of the impact United Way has on our partner agencies:

"Sarah is a 19 year old who has been a foster child for 5 years. She has been assigned the same CASA (Court Appointed Special Advocate) for the past 3.5 years in foster care. Sarah has lived in 10 different foster homes, bouncing between relative's homes, to residential homes, to traditional foster placements and now independent living. Due to her biological home trauma which included both abuse and neglect, Sarah has endured many traumas. Sarah's advocate has ensured that she received many child victim services including counseling and adequate support through a two-year criminal case as a victim. Like every child in foster care, Sarah dreamed of returning home and reuniting with her biological parents, however this dream couldn't become a reality.

Although Sarah has endured more than a lifetime of trauma in just 19 years, with the help of her consistent and caring advocate, she has been able to remarkably overcome these barriers and have many successes. Through five school changes as a teen, Sarah maintained honor roll. She worked two part-time jobs while attending high school. Sarah's advocate took her to a bank where she received lessons about financial literacy and together they opened Sarah's first checking and savings accounts. Within 9 months, Sarah was able to save up for her own car. As Sarah's high school career ended, her advocate helped her think about the future. The advocate then helped Sarah apply for college and for financial aid. Sarah's final foster placement was ending soon, so her advocate also helped her secure an apartment of her own. The advocate even reached out to family/friends to help Sarah furnish her apartment.

Sarah now attends the University of Illinois - Springfield. Sarah and her advocate continue to seek additional funding to help cover her cost of living expenses. They recently applied for a DCFS academic scholarship that, if awarded, would help Sarah with rent, gas, food and more.

Macon County CASA is fortunate to provide support and advocacy to currently over 260 local children who have been abused or neglected and removed from their biological homes. We do this with the help of our 138 currently active advocates. Many of these children, like Sarah, have endured the foster care system for too long. Their traumas can affect them their entire lives in very negative and detrimental ways. However, with the support of an advocate from CASA, the child is ensured a consistent friend, someone with whom they can re-build a sense of trust, and someone who is concerned only with that child's well-being and positive future. # 2019 COMMUNITY INVESTMENT - MOULTRIE & DEWITT COUNTY

"UWDMI will soon begin its Community Investment Process in DeWitt and Moultrie counties for 2019-2020. This will be the first year that UW will implement the Common Community Approach (CCA) in these counties. The CCA is a systematic approach to move members of our community who live in crisis on a path towards self-sufficiency. We want to move individuals out of crisis into stability, from stable to thriving, from thriving to self-sufficient and finally, we want to prevent them from moving from self-sufficiency back into crisis. This approach not only strengthens individuals, but also our community.

We will invest in programs along four Lines of Effort: Youth Education; Adult Education, Job Skills Development, & Income Resilience; Health; and Safety. Additionally, we will continue to ensure essential services are provided in our community. However, it is imperative that these services are also linking their clients to other programs that move them out of living a status-quo existence. Each Line of Effort investment recommendation will be made by a panel of community volunteers. These volunteers will rate each program based on its effectiveness, efficiency, and community integration. Most often, the highest-rated programs will receive the most investment.

UWDMI is committed to ensuring that investment received by the DeWitt and Moultrie communities is re-invested only into the DeWitt and Moultrie communities. It's true when we say, 'what's raised here stays here.' We look forward to the investment process this spring!"
