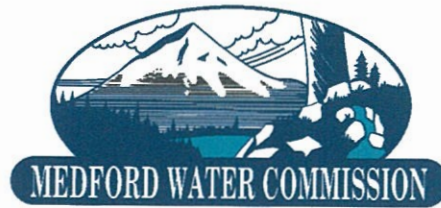

## 2016 Cost of Service Study SUMMARY

The effect of this analysis was to accurately adjust the revenue requirements for all customer groups. The Commission's last rate action went into effect on January 1, 2016. The analysis recommended monthly and gallonage charge modifications for all customer groups, effective March 1, 2017.

The proposed water consumption rates (per 1,000 gallons) and monthly charges are as follows:
