SB 0054 Use of Substances Affecting Cognitive Function by Sharief

Use of Substances Affecting Cognitive Function; Requiring medical examiners to take specified actions when performing an autopsy on a decedent who is a violent offender; requiring that autopsy reports for such individuals include certain findings and information; authorizing the release of certain patient records to law enforcement agencies without patient authorization under certain circumstances; requiring school safety specialists to provide school district staff with certain training on the adverse effects of specified substances, etc. Effective Date: 7/1/2026

Nursing Education Programs : Revises application requirements for nursing education program approval; authorizes Board of Nursing to revoke program's approval; revises requirements for annual reports program directors of approved programs are required to submit to board; provides for revocation of program's approval & discipline of its program director; revises remediation procedures; removes provision authorizing board to extend program's probationary status; authorizes agents of DOH to conduct onsite evaluations & inspections; authorizes DOH to collect evidence as part of such evaluations & inspections; removes provision authorizing approved nursing education programs to request extension to meet board's accreditation requirements. Health Care Patient Protection: Requires hospital emergency departments to develop & implement policies & procedures, conduct training, record weights in certain manner, designate pediatric emergency care coordinator, & conduct specified assessments; authorizes hospital with emergency department to conduct National Pediatric Readiness Project's Open Assessment under certain conditions; requires agency to adopt certain rules for comprehensive emergency management plans, and, in consultation with Florida Emergency Medical Services for Children State Partnership Program, establish minimum standards for pediatric patient care in hospital emergency departments; requires agency to collect & publish results of specified assessments submitted by hospitals by specified dates; provides requirements for collection & publication of such assessment scores. Effective Date: July 1, 2026

HB 0145 Suits Against the Government by McFarland

Suits Against the Government: Increases statutory limits on liability for tort claims against state & its agencies & subdivisions; authorizes subdivision of state to settle claim in excess of statutory limit without legislative action regardless of insurance coverage limits; prohibits insurance policy from conditioning benefits on enactment of claim bill; specifies that limitations in effect on date claim accrues apply to that claim; revises period within which certain claims must be presented; revises exceptions

relating to instituting tort claims against state or agencies or subdivisions; revises period after which failure of certain entities to make final disposition of claim shall be deemed final denial of claim for certain purposes; revises statute of limitations for tort claims against state or agencies or subdivisions & exceptions thereto. Effective Date: October 1, 2026

Civil Liability for the Wrongful Death of an Unborn Child: Revises definition of term "survivors" to include parents of unborn child; provides definition for term "unborn child"; prohibits right of action against mother for wrongful death of unborn child or against health care provider for lawful medical care provided in certain circumstances; authorizes parents of unborn child to recover certain damages; prohibits recovery of certain damages if decedent is unborn child. Effective Date: July 1, 2026

Availability of Marijuana for Adult Use; Revising the sales tax exemption for the sale of marijuana and marijuana delivery devices to apply only to purchases by qualified patients and caregivers; revising background screening requirements for caregivers; revising provisions related to the licensure and functions of medical marijuana treatment centers (MMTCs); authorizing MMTCs licensed to cultivate or process marijuana to use contractors to assist with the cultivation and processing of marijuana; authorizing MMTCs licensed to cultivate and process marijuana to sell marijuana at wholesale to other registered MMTCs only if certain conditions are met; requiring an MMTC to obtain a facility permit before selling, dispensing, or storing marijuana in a facility, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon becoming a law, this act shall take effect January 1, 2027

Civil Remedies Pertaining to Abortions; Defining the terms “clawback provision” and “family member”; creating a cause of action for certain violations relating to the induction or performance of an abortion; providing applicability; authorizing injunctive relief, recovery of damages, and reasonable costs and attorney fees; providing a limitation; prohibiting courts and authorities of this state from recognizing, enforcing, or giving effect to judgments or orders of another state issued under a clawback provision, with an exception; authorizing certain persons to bring a civil action against a person who initiated such actions in another state, etc. Effective Date: 7/1/2026

Advanced Air Mobility; Citing this act as the "Advanced Air Mobility Competitiveness and Infrastructure Act"; providing an exemption from the sales and use tax for certain electric vertical takeoff and landing aircraft and related items and for electricity used for certain training operations; defining the term "vertiport"; providing immunity from liability for certain vertiport operators; providing applicability; authorizing the department to fund up to specified percentages of vertiport project costs; requiring the department to expeditiously approve certain vertiports, etc. Effective Date: 7/1/2026
