CJA funds are to be primarily focused on the front-end, intake, assessment, investigative, and prosecutorial phases of child welfare. Chafee Foster Care Independence Act of 1999. The Independent Living Program is designed to assist and prepare foster and former foster youth in making the transition from foster care to adulthood by providing opportunities to obtain life skills for self-sufficiency and independence. Some young people who leave the foster care system may need continuing services and support to help them on their way to adulthood. Financial Assistance to Former Foster Your Program (FAFFY) Performance Period: July 1, 2021 through June 30, 2022	<p>Program Description The Nevada Independent Living Program is designed to assist and prepare foster and former foster youth in making the transition from foster care to adulthood by providing opportunities to obtain life skills for self-sufficiency and independence. Educational and Training Vouchers (ETV) Performance Period: October 1, 2021 through September 30, 2022	<p>Program Description ETV is designed to assist youth who have aged out of foster care anywhere in the United States and its territories can receive financial assistance in acquiring vocational and technical training or attending a college or university. Financial assistance is also available to youth who were adopted from foster care on or after their 16th birthday. To receive the educational voucher, you must attend an accredited school, minimally part-time and maintain a grade point average of 2.0 and/or make satisfactory progress in your education goals.</p> <p>Funding Available to</p> <ul style="list-style-type: none"> Nonprofit Community-based organizations School Districts Tribal governments, and Local Government Agencies <p>Service Target Population</p> <ul style="list-style-type: none"> Youth ages 16 to 21 years of age who will age out of the foster care system after turning 18 or for whom adoption from foster care was finalized at 16 or older. Students must apply each academic year. Students must attend, at least half-time, at an accredited school that (as defined by the institution): Awards a bachelor's degree or not less than a 2-year program that provides credit towards a degree, provides no less than 1-year of training towards gainful employment, or is a vocational program that provides training for gainful employment and has been in existence for at least two years; Students must maintain a GPA of 2.0 and/or make satisfactory progress in your educational goals. Students from other states who already receive ETV program and move to Nevada for the sole purpose of attending postsecondary or vocational school should continue to receive ETV program support from their original state of residence if they remain eligible for the program.
