Finance

Other Designated Receipts: <i>total offerings that were designated for other specific purposes, such as memorial gifts and special funds</i>	
Total Giving Received: <i>ALEX will calculate this total by adding the three lines above.</i>	<i>ALEX Calculated</i>
Per Capita Total Giving: <i>ALEX will calculate this value by dividing Total Giving Received by the reported number of Participants.</i>	<i>ALEX Calculated</i>
