

A MULTIDISCIPLINARY APPROACH TO ADDRESSING HOMELESNESS




S.M.A.R.T. Duties/Goals

- Responsible for creating a coordinated Department-wide response to issues pertaining to the unsheltered/homeless.
- Engender relationships that support the concept of "wrap around services."
- Reach the homeless community with services that assist them with becoming viable members of the community.
- Educate the public on their rights, responsibilities and legal resolutions should they become victimized by the homeless.
- * Reduce calls for service.
- Helping with getting them document ready for EHV/MVP (or other) Housing Vouchers

S.M.A.R.T. Mission

- SMART is tasked with analyzing environmental and societal factors related to the quality of life in Porterville as it relates to homelessness.
- SMART is tasked with developing strategies to mitigate these factors and building capacity for partnerships that produce sustainable outcomes to reduce homelessness.
- SMART is tasked with taking proper enforcement action against chronic violators of the law.
- SMART performs outreach with PATH on Wednesdays & other partners as needed.
- Build relationships, rapports and trust with chronically homeless (bus passes, clothing, transportation, ID vouchers, emotional support, pet food)
- * Identify, evaluate, and connect clients to appropriate mental health, substance use, and shelter/housing resources (Rapid-Rehousing, Permanent Supportive Housing, EHV and MVP vouchers)

- Homelessness is not a crime, can not enforce camping ordinances when shelter is not available
