

## Diocese of Northern California Sustainable Development Goals Grants

The Sustainable Development Goals Commission for the Episcopal Diocese of Northern California is pleased to announce the posting of the 2018 SDG grant applications. The funding of these grants comes from our resolution at the 2016 Diocesan Convention, following the lead of the United Nations and the Episcopal Church, that extends the commitment of using 0.7% of our budget for overseas development. The focus has shifted from relief of poverty, to efforts to help people and or communities develop ways to become self sustaining. Among the 17 stated goals are those including comprehensive education, better farming techniques, relief of hunger and economic growth.

The purpose of the grants is to provide congregations with start-up or expansion funds for ministry programs or projects which support one or more of the Sustainable Development Goals.

1) **SDG Grant Application:** These funds can be used to develop or expand SDG ministries or programs which address sustainability and with which congregations of the Episcopal Diocese of Northern California or other related organizations are involved.

### **Guidelines for Sustainable Development Goals Grants**

These guidelines are purposefully short, meant to encourage creativity and innovation rather than stifle new ministries through unreasonably constricting rules. It is the intention of the Sustainable Development Goals Commission that these grants fund new or expanded ministries which reflect the following:

**Involvement with a program or project which focuses on the issues of community sustainability as addressed in the Sustainable Development Goals.**

- \* The Program or project should reflect cooperation with the local community in discerning local needs and how to address them in partnership with the local community so that the project or program continues beyond the congregational involvement.
- \* The program or project should allow for involvement of members of the congregation in a variety of ways.

\* A congregation's involvement should offer opportunity for nurturing of spiritual growth and expansion of the vision of God's mission in the world.

- The ministry should be available as a model for other congregations and organizations in the Episcopal Diocese of Northern California and/or the larger Episcopal Church.
