COMPREHENSIVE LIST (BY REGION)

These local orders must now be read in light of [Executive Order 2020-91](#) and [Executive Order 2020-92](#), which supersede all conflicting local orders. Because this is a quickly-changing situation, please consult the State and your local government for the most up-to-date information.

MIAMI/SOUTH FLORIDA

BOCA RATON

- Subject to same directives with respect to essential and non-essential businesses as provided in Miami-Dade County Emergency Orders entered prior to March 30, 2020.
- Subject to Palm Beach County's Emergency Orders.

March 27, 2020 – Emergency Order (Stay Home, Stay Safe Order)

- All individuals must **remain in their homes or on their property**.
 - Exemptions include: when engaging in essential retail and commercial activities; when engaging in outdoor recreation activity, provided CDC guidance and social distancing measures are followed; caring for family member, friend or pet.

March 24, 2020

- **All nonessential retail and commercial businesses are ordered closed**.
- Essential businesses include but are not limited to:
 - Healthcare providers and public health operations.
 - Stores that sell groceries or non-grocery products, and products necessary to maintaining the safety, sanitation, and essential operations of residences.
 - Hardware, gardening, and building material stores.
 - Contractors and tradesmen.
 - Restaurants and facilities that prepare / serve food, subject to the limitations and requirements of Governor's Executive Orders 20-68, 20-70, and 20-71.
 - Businesses that primarily supply office products needed to work from home.
 - Businesses that primarily ship or deliver groceries, food, goods, or services directly to residents.
 - Financial institutions.

BROWARD COUNTY

- Subject to same directives with respect to essential and non-essential businesses as provided in Miami-Dade County Emergency Orders entered prior to March 30, 2020.

March 30, 2020 – Emergency Order 20-04

- All **golf courses and movie theaters** (including drive-in, indoor, and outdoor) to close.
- Clarifies **services related to real estate purchases** (appraisers, surveyors, etc.) as an essential business.
- Restricts more than 10 people from congregating around **restaurant or food truck**.
- All **food trucks** must remain at least 50 feet apart.
- Clarifies **businesses providing support to other essential businesses** must operate in full compliance with the CDC guidelines for social distancing.

RECENT COUNTY AND CITY GOVERNMENT ACTIONS COMPREHENSIVE LIST (BY REGION)

- Clarifies **essential employees** engaged in essential activity are exempt from any travel, curfew and other restrictions.

March 26, 2020 – Emergency Order 20-03 (Safer at Home Policy)

- **Strongly urges individuals to remain at home** unless engaging in essential activities.
- Permits **outdoor exercise** that complies with the CDC guidelines for social distancing.

March 23, 2020 – Emergency Order 20-02

- Clarifies prior Emergency Order to prohibit congregation of large parties at **marinas**.
- Clarifies prior Emergency Order to include **pawn shops** as an essential business.

March 22, 2020 – Emergency Order 20-01

- All **nonessential retail and commercial business are ordered closed**.
- Essential businesses include, but are not limited to:
 - Healthcare providers and public health operations.
 - Stores that sell groceries or non-grocery products, and products necessary to maintaining the safety, sanitation, and essential operations of residences.
 - Hardware, gardening, and building material stores.
 - Contractors and tradesmen.
 - Restaurants and facilities that prepare / serve food, subject to the limitations and requirements of Governor's Executive Orders 20-68, 20-70, and 20-71.
 - Businesses that primarily supply office products needed to work from home.
 - Businesses that primarily ship or deliver groceries, food, goods, or services directly to residents.
 - Financial institutions.
- **Nonessential businesses may conduct minimum business operations** to protect inventory, process payroll, etc.

DELRAY BEACH

- Subject to same directives with respect to essential and non-essential businesses as provided in Miami-Dade County Emergency Orders entered prior to March 30, 2020.
- Subject to Palm Beach County's Emergency Orders.

March 28, 2020 – Emergency Declaration (Stay-At-Home Order)

- All residents must **remain in their homes or on their property** unless engaging in essential activities, including but not limited to:
 - Seeking goods and services from essential retail and commercial businesses.
 - Obtaining assistance for emergency services.
 - Caring for a family member.
 - Performing work for an essential business.
 - Outdoor recreational activities, provided social distancing measures are followed.
- All **nonessential travel** prohibited.
- All **government employees and first/emergency responders** exempted from the Order.
- **Curfew** between the hours of 12:00am and 6:00am daily, with exceptions.

RECENT COUNTY AND CITY GOVERNMENT ACTIONS COMPREHENSIVE LIST (BY REGION)

- Requires **persons in public spaces** to practice social distancing.
- Requires persons to avoid public spaces if exhibiting symptoms of COVID-19.
- Prohibits **gatherings** of any number of people outside of a residence, except between family members, caretakers, or household members.

March 28, 2020 – Resolution No. 78-20

- All **nonessential retail and commercial establishments** to remain closed until April 16, 2020 (see Resolution 75-20).

March 20, 2020 – Resolution No. 75-20

- All **nonessential retail and commercial establishments** closed until March 31, 2020.
- Essential businesses include, but are not limited to:
 - Healthcare providers and public health operations.
 - Stores that sell groceries or non-grocery products, and products necessary to maintaining the safety, sanitation, and essential operations of residences.
 - Hardware stores.
 - Contractors and tradesmen.
 - Restaurants and facilities that prepare / serve food, subject to the limitations and requirements of Governor's Executive Orders 20-68, 20-70, and 20-71.
 - Businesses that primarily supply office products needed to work from home.
 - Businesses that primarily ship or deliver groceries, food, goods, or services directly to residents.
 - Financial institutions.
 - Veterinarians.

FORT LAUDERDALE

- Subject to same directives with respect to essential and non-essential businesses as provided in Miami-Dade County Emergency Orders entered prior to March 30, 2020.
- Subject to Broward County's Emergency Orders.

March 27, 2020 – Declaration of Emergency and “Safer At Home” Regulations

- All residents must **remain in their homes or on their property** unless engaging in essential activities, including but not limited to:
 - Seeking goods and services from essential retail and commercial businesses.
 - Obtaining assistance for emergency services.
 - Caring for a family member, friend, pet, etc.
 - Performing work for an essential business.
 - Outdoor recreational activities, provided social distancing measures are followed.
 - Religious activities, provided social distancing measures are followed.
- All **nonessential travel** prohibited.
- All **government employees and first/emergency responders** exempted from the Order.
- Requires **persons in public spaces** to practice social distancing.
- Requires persons to avoid public spaces if exhibiting symptoms of COVID-19.

RECENT COUNTY AND CITY GOVERNMENT ACTIONS COMPREHENSIVE LIST (BY REGION)

- All **essential businesses** required to engage in cleaning protocols, implement employee screening, and prohibit any employee from entering the premises under certain conditions.
- Limits **gatherings of 10 or more people** except for essential businesses.

March 17, 2020 - Declaration of Emergency Regulations

- All **public gatherings** of any type, whether organized or otherwise, of greater than 10 persons are prohibited.
 - Exemptions include but are not limited to: grocery stores, gas stations, convenience stores, banks, credit unions, financial institutions, hardware stores, auto supply stores, hospitals, healthcare and medical facilities, pharmacies, drug stores, medical supply companies.
- All bars, nightclubs, taverns, pubs, cocktail lounges, breweries, dance halls, movie theaters, halls for hire, auditoriums, bowling alleys, video arcades, and other like **entertainment facilities** and businesses, including but not limited to those contained within a hotel or other enclosed facility or structure, shall close.
- All **gyms, fitness centers, fitness studios, dance studios, and gymsnasiums** shall close.
 - Exemptions include: gymsnasiums, fitness centers, and fitness studios which:
 - (a) are amenities of hotels or office buildings and which have a capacity of 10 persons or less; or (b) are an amenity of residential buildings.
- All restaurants, cafeterias, and other **food service establishments** are mandated to cease all on-premises service.
 - However, such establishments may continue to operate their kitchens for drive-thru, delivery, take-out, and exterior pick-up food services.
- **Businesses that are permitted to remain open must offer hand sanitizer at every entrance.**

HOMESTEAD

- Subject to Miami-Dade County's Emergency Orders.

March 27, 2020 – Order

- **Curfew** from 10:00pm to 5:00am, with exceptions for emergencies, walking dogs, etc.

GOLDEN BEACH

- Subject to Miami-Dade County's Emergency Orders.

March 23, 2020 – “Safer At Home” Emergency Order

- All persons **urged to stay home** unless engaging in essential activity, including but not limited to:
 - Seeking goods and services from essential retail and commercial businesses.
 - Obtaining assistance for emergency services.
 - Caring for a family member, friend, or pet.
 - Performing work for an essential business.

RECENT COUNTY AND CITY GOVERNMENT ACTIONS COMPREHENSIVE LIST (BY REGION)

- Outdoor recreational activities, provided social distancing measures are followed.
- All **government employees and first/emergency responders** exempted from the Order.
- Requires all persons engaging in permitted activities to practice social distancing.

March 21, 2020

- All **construction sites** closed until further notice.
- Anything other than **simple landscaping** (leaf blowing, lawn mowing) is prohibited until further notice.
- Emergency home repairs (AC, electrical, cable, plumbing, etc.) must get approval from Town Manager.
- **Any providers of nonexempt services that are not essential to health or well-being will not be allowed to enter the Town.**
- **Curfew** in effect from 8:00pm to 6:00am.

HALLANDALE BEACH

- Subject to same directives with respect to essential and non-essential businesses as provided in Miami-Dade County Emergency Orders entered prior to March 30, 2020.
- Subject to Broward County's Emergency Orders.

March 24, 2020 – Declaration of Emergency Regulations Order 20-03

- **Curfew** from 11:00pm to 5:00am, with certain exceptions for emergencies, walking a dog, going to or from work, etc.
- All **pools and gyms** in common area of hotels, homeowners associations or condominiums to close.
- Requires adherence to social distancing and sanitation practices in performing any permitted activities.

March 17, 2020 – Declaration of Emergency Regulation Order 20-02

- All restaurants, bars, pubs, night clubs, banquet halls, breweries, cafeterias, and other **alcohols and/or food service business establishment** with seating more than eight people ordered closed for on-premises service.
- All **movie theaters, bowling alleys, gyms and fitness studios** ordered closed.
 - Exemptions include: gymnasiums, fitness centers, and fitness studios which: (a) are amenities of hotels or office buildings and which have a capacity of 10 persons or less; (b) are an amenity of residential buildings; (c) interior to any fire or police station; or (d) located within any single-occupant office building.
- All **public gatherings** in excess of 250 people prohibited.

KEY BISCAYNE

- Subject to same directives with respect to essential and non-essential businesses as provided in Miami-Dade County Emergency Orders entered prior to March 30, 2020.
- Subject to Monroe County's Emergency Orders.

RECENT COUNTY AND CITY GOVERNMENT ACTIONS COMPREHENSIVE LIST (BY REGION)

March 22, 2020 – Emergency Order 20-03

- Prohibits **non-residential travel**.
 - Exemptions include individuals providing essential government functions and essential business employees (as defined by Miami-Dade County Executive Order 07-20)

March 18, 2020 – Emergency Order 20-02

- All public beaches closed, except individuals running or walking.

March 16, 2020 – Emergency Order 20-01

- **Curfew** between the hours of 10:00pm and 5:00am until further notice. No person shall be outside during curfew hours unless:
 - Providing police, fire, or other governmental services
 - Providing assistance expressly requested by police, fire, or the Village
 - Participating in, going to, or returning from work

KEY WEST

- Subject to same directives with respect to essential and non-essential businesses as provided in Miami-Dade County Emergency Orders entered prior to March 30, 2020.
- Subject to Monroe County's Emergency Orders.

March 23, 2020 - Emergency Directive 2020-03

- All **nonessential retail and commercial business** are ordered closed.
- Essential businesses include, but are not limited to:
 - Healthcare providers and public health operations.
 - Stores that sell groceries or non-grocery products, and products necessary to maintaining the safety, sanitation, and essential operations of residences.
 - Hardware, gardening, and building material stores.
 - Contractors and tradesmen.
 - Restaurants and other facilities that prepare and serve food, but subject to the limitations and requirements of the Governor's Executive Order 20-71.
 - Businesses that primarily supply office products needed to work from home.
 - Businesses that primarily ship or deliver groceries, food, goods, or services directly to residents.
 - Financial institutions.
- No **vacation rentals** to tourists for 14 days (starting on Sunday, March 22, 2020), except that contracts of 28 days or more may continue to the conclusion of the contract.

March 19, 2020 - Emergency Directive 2020-02

- Limits gatherings of 10 or more people.

MIAMI

- Subject to Miami-Dade County's Emergency Orders.

March 26, 2020 – Order No. 20-05

RECENT COUNTY AND CITY GOVERNMENT ACTIONS COMPREHENSIVE LIST (BY REGION)

- **Curfew** from 10:00pm to 5:00am, with certain exceptions for emergencies, walking a dog, going to or from work, food deliveries, etc.

March 24, 2020 – Order No. 20-04 (Shelter In Place)

- All residents ordered to **remain in their residences** unless engaging in essential activities, including but not limited to:
 - Seeking goods and services from essential retail and commercial businesses.
 - Performing work for an essential business.
 - Outdoor recreational activities, provided social distancing measures are followed.
- Prohibits **nonessential travel**.
- All **alcohol service establishments** that do not serve food to close.
- All **restaurants**, except for delivery, carry-out and drive-thru services to close.
- All **movie theaters, bowling alleys, etc.** to close.
- All **gyms and fitness centers** to close.
- All **casinos, cardrooms, racetracks, etc.** to close.
- **Essential businesses** may continue to operate provided occupancy loads remain under 50%. If such load is 500 or greater, occupancy shall not exceed 250 persons at any time.
- All **nonessential businesses** must remain closed.
- **Unconscionable pricing** banned.

MIAMI BEACH

- Subject to Miami-Dade County's Emergency Orders.

March 28, 2020 – Emergency Measures

- **Curfew** from 12:00am to 5:00am except to provide designated essential services, such as first responders, food delivery, travel to and from essential work, etc.
- All **sidewalk cafes** shall close.
- All **nonessential businesses** shall closed.
 - Exemptions include: essential businesses as defined in Miami-Dade County Executive Order 07-20.
- All **gyms, fitness centers, fitness studios, dance studios, and gymnasiums** shall close.
 - Exemptions include: gymnasiums, fitness centers, and fitness studios which:
 - (a) are amenities of hotels or office buildings and which have a capacity of 10 persons or less; (b) are an amenity of residential buildings; (c) interior to any fire or police station; or (d) located within any single-occupant office building.
- All **massage therapy centers and spas** operating within hotels shall close.
- All **commercial lodging establishments** are closed and cannot accept guests or make reservations for the booking period of March 24, 2020-April 22, 2020.
- All **restaurants** are closed except for delivery, drive-thru or take-out services.
- Gatherings within **religious institutions** are prohibited.

MIAMI DADE COUNTY

RECENT COUNTY AND CITY GOVERNMENT ACTIONS COMPREHENSIVE LIST (BY REGION)

March 31, 2020 – Emergency Order 15-20

- All common use amenities, such as pools, golf courses, tennis courts, basketball courts, and fitness centers shall close.
 - Exceptions include: amenities located on a single family residential lot, any townhouse, duplex, or villa if such use is limited to the inhabitants of such dwelling unit.

March 28, 2020 – Emergency Order 14-20

- All plans review, issuance of permits, building inspections, etc. are suspended.
 - Applies to the Unincorporated Municipal Services Area of Miami-Dade County and all other areas within municipalities under the jurisdiction of the Miami-Dade County Building Official.

March 27, 2020 – Emergency Order 13-20

- All essential businesses to use reasonable efforts to ensure that customers and employees maintain appropriate social distancing, particularly in checkout, pick-up, or take-out areas.

March 26, 2020 – Emergency Order 12-20

- Refers to the totality of Emergency Orders issued as the Safer At Home protocols.
- All residents and visitors urged to remain at home unless engaging in an essential activity.

March 25, 2020 – Emergency Order 11-20

- All persons over 65 years of age and persons with serious underlying medical conditions urged to stay home and otherwise limit risk of exposure to COVID-19.
- All employers urged to allow persons over 65 years of age and persons with serious underlying medical conditions to work remotely or provide flexibility with leave time to ensure protections.
- All employers urged to allow any employee with ability to work remotely to do so.

March 25, 2020 – Amendment No. 1 to Emergency Order 09-20

- All hotels, motels, and short term vacation rentals prohibited from accepting any occupants or extend reservations except for essential lodgers.

March 24, 2020 – Emergency Order 10-20

- Prohibits groups of 10 or more individuals from gathering in public places
 - Excludes government employees providing services in the public area, interior roadways to the Port and Airport, individuals traveling within vehicles or mass transit, individuals waiting at bus stops, and individuals responding to an emergency.
- Urges individuals to remain home, except to engage in essential activities, which include travel to or from essential businesses as defined in Emergency Order 07-20.

March 23, 2020 – Amendment No. 3 to Emergency Order 07-20

- Amended Emergency Order 07-20 to clarify essential use of marinas

March 21, 2020 – Emergency Order 09-20

- All hotels, motels, short-term vacation rentals and other commercial lodging establishments shall not accept new reservations other than for essential lodgers.

COMPREHENSIVE LIST (BY REGION)

- Maximum occupancy for short-term vacation rentals shall be two persons per bedroom plus two additional persons per property, not to exceed 10 persons.

March 21, 2020 – Emergency Order 08-20

- “Rafting” (a tethering of boats to allow passengers to pass from one boat to another) is prohibited.

March 21, 2020 – Amendment No. 2 to Emergency Order 07-20

- Clarifies and adds to the list of essential businesses, to include but are not limited to:
 - Sale of alcoholic beverages.
 - Firearm and ammunition supplies.
 - Businesses providing services to government.

March 19, 2020 – Amendment No. 1 to Emergency Order 07-20

- Clarifies and adds to the list of essential businesses, to include but are not limited to:
 - College residence halls to the extent needed to accommodate students that cannot return home.
 - Marinas.
 - Hotels, motels, and other commercial lodging.
 - Veterinarians and pet boarding.
 - Mortuaries, funeral homes.

March 19, 2020 – Emergency Order 07-20

- All **nonessential retail and commercial establishments** are ordered closed.
- Essential businesses include, but are not limited to:
 - Healthcare providers and public health operations.
 - Stores that sell groceries or non-grocery products, and products necessary to maintaining the safety, sanitation, and essential operations of residences.
 - Hardware, gardening, and building material stores.
 - Contractors and tradesmen.
 - Restaurants and other facilities that prepare and serve food, but subject to the limitations and requirements of the Governor’s Executive Order 20-71.
 - Businesses that primarily supply office products needed to work from home.
 - Businesses that primarily ship or deliver groceries, food, goods, or services directly to residents.
 - Financial institutions.

MONROE COUNTY

- Subject to same directives with respect to essential and non-essential businesses as provided in Miami-Dade County Emergency Orders entered prior to March 30, 2020.

Anticipated Actions

- No order yet specifically defining “essential” businesses. It will be discussed on March 31, 2020. County administrators may determine additional “essential” businesses.

March 20, 2020 – Emergency Directive 20-02 (Tourist Ban)

- **Florida Keys closed to visitors.**

NORTH MIAMI

- Subject to Miami-Dade County's Emergency Orders.

March 30, 2020 – “Safer At Home” Emergency Order

- All persons urged to remain in homes, unless engaging in essential activities, including but not limited to:
 - Seeking goods and services from essential retail and commercial businesses.
 - Outdoor recreational activities, provided social distancing measures are followed.
 - Providing personal support to friend, family member, or pet.
 - Working in support of essential activity
- All public and private gatherings are prohibited, except for essential activities and activities within a single household.
- All nonessential travel prohibited.
- All government employees and first/emergency responders exempted from the Order.

March 17, 2020

- Curfew between the hours of 10:00pm and 5:00am until further notice. Any places of public assemblage shall be closed to the public during these hours, including all restaurants, bars and clubs. No person shall be outside or standing, parking or traveling in a vehicle during curfew hours unless:
 - Providing police, fire, or other governmental services
 - Providing assistance expressly requested by police, fire, or the City
 - Transporting medical patients,
 - Providing emergency utility repairs,
 - Participating in, going to, or returning from work

PALM BEACH COUNTY

- Subject to same directives with respect to essential and non-essential businesses as provided in Miami-Dade County Emergency Orders entered prior to March 30, 2020.

March 29, 2020 – Emergency Order 2020-003a (Stay Home - Safer-at-Home Policy)

- All individuals urged to stay home except to perform critical activities, including but not limited to:
 - Health and safety.
 - Obtain necessary services or supplies.
 - Care for family member, friend, or pet.
 - Engage in outdoor exercise, provided such exercise complies with CDC guidelines for social distancing.

- Engage in minimum activities necessary for basic operations or to patronize essential businesses.

March 29, 2020 – Emergency Order 2020-002a

- All **noncritical retail and commercial business locations** ordered to close except to perform minimum basic operations, such as but not limited to:
 - Protecting inventory.
 - Processing payroll.
 - Facilitating employees working remotely.
- **Critical businesses** include, but are not limited to:
 - Healthcare providers and public health operations.
 - Stores that sell groceries or non-grocery products, and products necessary to maintaining the safety, sanitation, and essential operations of residences.
 - Hardware, gardening, and building material stores.
 - Contractors and tradesmen.
 - Restaurants and facilities that prepare / serve food, subject to the limitations and requirements of Governor's Executive Orders 20-68, 20-70, and 20-71.
 - Businesses that primarily supply office products needed to work from home.
 - Businesses that primarily ship or deliver groceries, food, goods, or services directly to residents.
 - Financial institutions.

March 23, 2020 – Emergency Order 2020-001a

- All boat ramps, marinas, etc. are closed except that commercial fishing operations may continue.
- All islands, sandbars, and intracoastal lands are prohibited for use by the public.

PALM BEACH

- Subject to same directives with respect to essential and non-essential businesses as provided in Miami-Dade County Emergency Orders entered prior to March 30, 2020.
- Subject to Palm Beach County's Emergency Orders.

March 27, 2020 – Emergency Order No. 2020-01 (Directing Shelter In Place – “Safer At Home”)
