BOCA RATON

March 24, 2020

- **All nonessential retail and commercial businesses are ordered closed.**
- Essential businesses include but are not limited to:
 - Healthcare providers and public health operations.
 - Stores that sell groceries or non-grocery products, and products necessary to maintaining the safety, sanitation, and essential operations of residences.
 - Hardware, gardening, and building material stores.
 - Contractors and tradesmen.
 - Restaurants and other facilities that prepare and serve food, but subject to the limitations and requirements of the Governor's Executive Orders 20-68, 20-70, and 20-71.
 - Businesses that primarily supply office products needed for people to work from home.

BROWARD COUNTY

March 23, 2020 – Emergency Order 20-02

- Clarified prior Emergency Order to prohibit congregation of large parties at marinas.
- Clarified prior Emergency Order to include pawn shops as an essential business.

March 22, 2020 – Emergency Order 20-01

- All **nonessential retail and commercial business are ordered closed.**
- Essential businesses include, but are not limited to:
 - Healthcare providers and public health operations.
 - Stores that sell groceries or non-grocery products, and products necessary to maintaining the safety, sanitation, and essential operations of residences.
 - Hardware, gardening, and building material stores.
 - Contractors and tradesmen.
 - Restaurants and other facilities that prepare and serve food, but subject to the limitations and requirements of the Governor's Executive Orders 20-68, 20-70, and 20-71.
 - Businesses that primarily supply office products needed for people to work from home.
 - Businesses that primarily ship or deliver groceries, food, goods, or services directly to residents.
 - Financial institutions.

DELRAY BEACH

- Subject to Palm Beach County's Emergency Orders.

March 20, 2020 – Resolution No. 75-20

- **All nonessential retail and commercial establishments closed until March 31, 2020.**
- Essential businesses include, but are not limited to:
 - Healthcare providers and public health operations.
 - Stores that sell groceries or non-grocery products, and products necessary to maintaining the safety, sanitation, and essential operations of residences.
 - Hardware stores.
 - Contractors and tradesmen.
 - Restaurants and other facilities that prepare and serve food, but subject to the limitations and requirements of the Governor's Executive Orders 20-68, 20-70, and 20-71.
 - Businesses that primarily supply office products needed for people to work from home.
 - Businesses that primarily ship or deliver groceries, food, goods, or services directly to residents.
 - Financial institutions.
 - Veterinarians.

FORT LAUDERDALE

- Subject to Broward County's Emergency Orders.

March 17, 2020 (Effective March 17-April 16, 2020)

- All **public gatherings** of any type, whether organized or otherwise, of greater than 10 persons are prohibited.
 - Exemptions include but are not limited to: grocery stores, gas stations, convenience stores, banks, credit unions, financial institutions, hardware stores, auto supply stores, hospitals, healthcare and medical facilities, pharmacies, drug stores, medical supply companies.
- All bars, nightclubs, taverns, pubs, cocktail lounges, breweries, dance halls, movie theaters, halls for hire, auditoriums, bowling alleys, video arcades, and other like **entertainment facilities** and businesses, including but not limited to those contained within a hotel or other enclosed facility or structure, shall close.
- All gyms, fitness centers, fitness studios, dance studios, and gymnasiums shall close.
 - Exemptions include: gymnasiums, fitness centers, and fitness studios which:
 - (a) are amenities of hotels or office buildings and which have a capacity of 10 persons or less; or (b) are an amenity of residential buildings.
- All restaurants, cafeterias, and other **food service establishments** are mandated to cease all on-premises service.
 - However, such establishments may continue to operate their kitchens for drive-thru, delivery, take-out, and exterior pick-up food services.
- All **City parks**, including recreational facilities, are closed.

March 19, 2020

- **All nonessential businesses shall close.**
 - Pharmacies, gas stations, and grocery stores to operate as normal.
 - All restaurant kitchens may remain open for takeout and delivery only.

GOLDEN BEACH

- Subject to Miami-Dade County's Emergency Orders.

March 21, 2020

- All **construction sites** to cease starting March 16 until further notice.
- Anything other than **simple landscaping** (leaf blowing, lawn mowing) is prohibited until further notice.
- Emergency home repairs (AC, electrical, cable, plumbing, etc.) must get approval from Town Manager.
- **Any providers of nonexempt services that are not essential to health or well-being will not be allowed to enter the Town.**
- **Curfew** in effect from 8:00 p.m. to 6:00 a.m.

HALLANDALE BEACH

- Subject to Broward County's Emergency Orders.

March 23, 2020

- All **gathering/entertainment facilities** shall close.
- All local **restaurants** to move to delivery/pick-up operations only and suspend their dining room operations.
- All **beaches** are closed.

KEY BISCAYNE

March 22, 2020 – Emergency Order 20-03

- **Prohibits non-residential travel.**
 - Exemptions include individuals providing essential government functions and essential business employees (as defined by Miami-Dade County Executive Order 07-20)

March 18, 2020 – Emergency Order 20-02

- All public beaches closed, except individuals running or walking.

March 16, 2020 – Emergency Order 20-01

- **Curfew** between the hours of 10:00pm and 5:00am until further notice. No person shall be outside during curfew hours unless:

KEY WEST

March 23, 2020 - Emergency Directive 2020-03

- All **nonessential retail and commercial business are ordered closed**.
- Essential businesses include, but are not limited to:
 - Healthcare providers and public health operations.
 - Stores that sell groceries or non-grocery products, and products necessary to maintaining the safety, sanitation, and essential operations of residences.
 - Hardware, gardening, and building material stores.
 - Contractors and tradesmen.
 - Restaurants and other facilities that prepare and serve food, but subject to the limitations and requirements of the Governor's Executive Order 20-71.
 - Businesses that primarily supply office products needed for people to work from home.
 - Businesses that primarily ship or deliver groceries, food, goods, or services directly to residents.
 - Financial institutions.
- No vacation rentals to tourists for 14 days (starting on Sunday, March 22, 2020), except that contracts of 28 days or more may continue to the conclusion of the contract.

March 19, 2020 - Emergency Directive 2020-02

- Limits gatherings of 10 or more people.

MIAMI

- Subject to Miami-Dade County's Emergency Orders.

March 19, 2020 - Order No. 20-03

- All **alcohol service establishments** (that do not serve food) shall close.
- All **restaurants and retail food facilities** prohibited from serving food for consumption in dining areas on premises, including outdoor seating areas. Restaurants and retail food facilities may continue to operate for food delivery.
 - Exemptions include: Cafeterias, commissaries, restaurants located entirely within hospitals, nursing homes, or similar facilities, grocery stores, pharmacies, food banks.
- All movie theaters, live performance venues, bowling alleys, arcades, gyms and fitness centers, casinos, card-rooms, frontons, racetracks and pari-mutuel facilities shall be closed.
- No businesses or establishments shall operate if the total occupancy exceeds 50% of the authorized total occupancy load.
- All **nonessential businesses** are closed to the public.

MIAMI BEACH

- Subject to Miami-Dade County's Emergency Orders.

March 23, 2020 (Effective March 24-26, 2020)

- "Safer At Home" Order issued—All persons living within the City of Miami Beach are hereby ordered to remain in their homes.
- All public and private gatherings of any number of people occurring outside a residence are prohibited.
- All travel, including, without limitation, travel on foot, bicycle, scooter, motorcycle, automobile, or use of public transit is prohibited.
- Exemptions include but are not limited to:
 - Essential retail and commercial activities, as defined in Miami-Dade County's Emergency Order 07-20.
 - Outdoor recreational activities.
 - Religious activities (no more than 10 persons).
 - Personal support activities.
 - Government employees and emergency personnel.

March 20, 2020 (Effective March 21-26, 2020)

- Curfew from 12:00 a.m. (midnight) to 5:00 a.m. daily, except for emergency and food delivery services.
- All **nonessential businesses** are closed.
 - Exemptions include essential businesses as defined in Miami-Dade County Executive Order 07-20.
- All gyms, fitness centers, fitness studios, dance studios, and gymnasiums shall close.
 - Exemptions include: gymnasiums, fitness centers, and fitness studios which:
(a) are amenities of hotels or office buildings and which have a capacity of 10 persons or less; (b) are an amenity of residential buildings; (c) interior to any fire or police station; or (d) located within any single-occupant office building.
- Requires closure of all massage therapy centers and spas operating within hotels.
- All commercial lodging establishments are closed and cannot accept guests or make reservations for the booking period of March 24-April 22, 2020.
- All restaurants are closed except for delivery, drive-thru or take-out services.

RECENT COUNTY AND CITY GOVERNMENT ACTIONS

MIAMI DADE COUNTY

March 24, 2020 – Emergency Order 10-20

- Prohibits groups of 10 or more individuals from gathering in public places
 - Excludes government employees providing services in the public area, interior roadways to the Port and Airport, individuals traveling within vehicles or mass transit, individuals waiting at bus stops, and individuals responding to an emergency.
- Individuals “urged” to remain home, except to engage in essential activities, which include travel to or from essential businesses as defined in Emergency Order 07-20.

March 23, 2020 – Amendment No. 3 to Emergency Order 07-20

- Amended Emergency Order 07-20 to clarify essential use of marinas

March 21, 2020 – Emergency Order 09-20

- All **hotels, motels, short-term vacation rentals and other commercial lodging establishments** shall not accept new reservations other than for essential lodgers.
- Maximum occupancy for short-term vacation rentals shall be two persons per bedroom plus two additional persons per property, not to exceed 10 persons.

March 21, 2020 – Emergency Order 08-20

- “Rafting” (a tethering of boats to allow passengers to pass from one boat to another) is prohibited.

March 21, 2020 – Amendment No. 2 to Emergency Order 07-20

- Clarifies and adds to the list of essential businesses, to include but are not limited to:
 - Sale of alcoholic beverages.
 - Firearm and ammunition supplies.
 - Businesses providing services to government.

March 19, 2020 – Amendment No. 1 to Emergency Order 07-20

- Clarifies and adds to the list of essential businesses, to include but are not limited to:
 - College residence halls to the extent needed to accommodate students that cannot return home.
 - Marinas.
 - Hotels, motels, and other commercial lodging.
 - Veterinarians and pet boarding.
 - Mortuaries, funeral homes.

March 19, 2020 – Emergency Order 07-20

- All **nonessential retail and commercial establishments** are ordered closed.
- Essential businesses include, but are not limited to:
 - Healthcare providers and public health operations.
 - Stores that sell groceries or non-grocery products, and products necessary to maintaining the safety, sanitation, and essential operations of residences.
 - Hardware, gardening, and building material stores.
 - Contractors and tradesmen.
 - Restaurants and other facilities that prepare and serve food, but subject to the limitations and requirements of the Governor’s Executive Order 20-71.

- **Florida Keys closed to visitors.**
- No lodging establishment may accept reservations.
- No vacation rentals to tourists for 14 days (starting on Sunday, March 22, 2020), except that military personnel, health care workers, first responders, construction workers actively engaged in projects, and others engaged in formal business may rent vacation rentals.

NORTH MIAMI

- Subject to Miami-Dade County's Emergency Orders.

March 17, 2020

- **Curfew** between the hours of 10:00pm and 5:00am until further notice. Any places of public assemblage shall be closed to the public during these hours, including all restaurants, bars and clubs. No person shall be outside or standing, parking or traveling in a vehicle during curfew hours unless:
 - Providing police, fire, or other governmental services
 - Providing assistance expressly requested by police, fire, or the City
 - Transporting medical patients,
 - Providing emergency utility repairs,
 - Participating in, going to, or returning from work

PALM BEACH COUNTY

March 23, 2020 – Emergency Order 2020-001a

- All boat ramps, marinas, etc. are closed except that commercial fishing operations may continue.
- All islands, sandbars, and intracoastal lands are prohibited for use by the public.

PALM BEACH

- Subject to Palm Beach County's Emergency Orders.

March 17, 2020

- **Curfew** between the hours of 9:00pm and 6:00am each day.
 - All non-essential and non-emergency travel strongly discouraged during curfew.
 - Exemptions to the curfew exist for Town residents, Town ID holders, and medical personnel conducting essential and emergency travel.
- All **public beaches** are closed.

 - Stores that sell groceries or non-grocery products, and products necessary to maintaining the safety, sanitation, and essential operations of residences.
 - Hardware, gardening, and building material stores.
 - Contractors and tradesmen.
 - Restaurants and other facilities that prepare and serve food, but subject to the limitations and requirements of the Governor's Executive Orders 20-68, 20-70, and 20-71.
 - Businesses that primarily supply office products needed for people to work from home.
 - Businesses that primarily ship or deliver groceries, food, goods, or services directly to residents.
 - Financial institutions.

WILTON MANORS

- Subject to Broward County's Emergency Orders.

March 18, 2020 – Emergency Order 2020-002 (Effective March 18- April 16, 2020)

- All **public gatherings** of greater than 10 persons are prohibited.
 - Exemptions include: grocery stores, gas stations, convenience stores, banks, credit unions, financial institutions, hardware stores, auto-supply stores, hospitals, healthcare and medical facilities, pharmacies, drug stores, medical supply companies, land or facilities owned and managed by Broward County, the Broward County School Board, the North Broward Hospital District, the State of Florida, and the Federal Government.
- All bars, nightclubs, taverns, pubs, cocktail lounges, breweries, dance halls, movie theaters, halls for hire, auditoriums, bowling alleys, video arcades, and other like **entertainment facilities** and businesses, including but not limited to those contained within a hotel or other enclosed facility or structure, shall close.
- All gyms, fitness centers, fitness studios, dance studios, and gymnasiums shall close.
 - Exemptions include: gymnasiums, fitness centers, and fitness studios which: (a) are amenities of hotels or office buildings and which have a capacity of 10 persons or less; or (b) are an amenity of residential buildings.
- All restaurants, cafeterias, and other **food service establishments** are mandated to cease all on-premises service.
 - However, such establishments may continue to operate their kitchens for drive-thru, delivery, take-out, and exterior pick-up food services.

COLLIER COUNTY

March 20, 2020

- All **public beaches** are closed.

LEE COUNTY

- No significant additional restrictions imposed at this time.

TAMPA BAY/WEST FLORIDA

CLEARWATER

March 18, 2020

- All **in-person gatherings** consisting of 10 or more people are prohibited.
 - Exemptions include: critical infrastructure and public safety and health functions.
- All **restaurants** to cease sales of all alcoholic beverages no later than 10:00 pm.
- All **public places, buildings, and facilities** (including all businesses, restaurants, bars, and retail establishments) shall have alcohol-based hand sanitizer (so long as publicly available) at every entrance.
 - Exemptions include: public parks.
- No **person or business entity offering goods or services for sale** shall charge more than the normal average retail price during the period of the declared emergency.
- Clearwater **Beach** will be closed from March 21 to April 6.

HILLSBOROUGH COUNTY

Anticipated Actions

- Curfew and Stay At Home Order to be considered on Wednesday.

March 24, 2020 – Administrative Order No. 20-06

- Confirms that no Stay At Home Order has been directed.

March 20, 2020 – Administrative Order No. 20-05

- Prohibits **public and private gatherings of more than 10 people** except in venues that provide essential goods and services, such as grocery stores and medical facilities.

PASCO COUNTY

- No significant additional restrictions imposed at this time.

PINELLAS COUNTY

March 25, 2020 - Emergency Directive (DRAFT)

- “Safer At Home” Order issued.

- Requires local governments to post the Order and provides a number to call to report businesses not respecting social distancing measures.

March 19, 2020 – Resolution No. 20-17

- **Public beaches** closed until April 6, 2020.

SARASOTA COUNTY

March 20, 2020

- All **County beaches** closed.

SARASOTA

- No significant additional restrictions imposed at this time.

ST. PETERSBURG

- Subject to Pinellas County Emergency Directives.

Anticipated Actions

- Stay At Home Order is expected.

March 19, 2020 – Executive Order 2020-04

- All events or **public gatherings** on public and private property that consist of more than 50 people are prohibited.
 - Examples include: festivals, parades, concerts, sporting events, parties, weddings, and similar assemblies.
- Occupancy of places of public assemblage is reduced to 50%.
 - Examples include: arenas, amusement parks, concert halls, gyms, and theaters.
- Last call for alcohol is 9:00 p.m.

TAMPA

Anticipated Actions

- Stay At Home Order is expected, effective after midnight on March 25, 2020.

March 17, 2020 – Mayoral Order No. 1

- All **restaurants, private clubs, bars, or other establishments that offer food or drink for sale** for on-premises consumption shall close daily no later than 10:00 PM and remain closed until at least 6:00 AM the following day (or such other time as permitted pursuant to law or permit).

ORLANDO/CENTRAL FLORIDA

 - Obtaining necessary supplies.
 - Outdoor activities.
 - Essential business (defined in Order).

GAINESVILLE

- Subject to Alachua County's Emergency Orders.

March 17, 2020 – Emergency Directive No. 2020-02

- All **nonessential places of public assembly that serve food and/or beverages** are limited to 50% capacity or 50 persons, whichever is less. Limited hours of operations to 6 a.m. to 9 p.m. will be limited to service at tables with access to hand sanitizer, a 6-foot minimum distance between any group of patrons, and party limit of 10 individuals or less.

ORANGE COUNTY

- **Stay At Home Order issued**—Individuals cannot leave their primary residence except under the following circumstances:
 - Basic needs.
 - Physical activity and exercise (outdoor activities).
 - Travel related to provision or receipt of essential service.
 - Travel to home from out of the County and travel to transportation hubs.
- All **nonessential retail and commercial business are ordered closed**.
- Essential businesses include, but are not limited to:
 - Healthcare providers and public health operations.

- **Sale of alcohol** in bars, restaurants and nightclubs banned for on-premise consumption for the duration of the month of March. Excludes sale of alcohol for home consumption, such as liquor stores.

JACKSONVILLE/NORTHWEST FLORIDA

ATLANTIC BEACH

March 16, 2020

- All **alcohol** sales, outside of grocery stores, banned from 12:00am to 8:00am.

DUVAL COUNTY/JACKSONVILLE

March 23, 2020 – Emergency Executive Order No. 2020-3

- **All businesses must allow employees to work remotely, if possible.** At all times, employees must remain 6 feet apart.

March 20, 2020 – Emergency Executive Order No. 2020-2

- All **public beaches** closed.

March 16, 2020 – Emergency Executive Order No. 2020-1

- All **retail, entertainment and places of assembly** are limited to a maximum capacity of 50 persons.
 - Exemptions include: office buildings, manufacturing plants, grocery stores, and many other businesses.
- **Alcohol sales** (on-premises and off-premises consumption) are prohibited between 12:00 a.m. and 8:00 a.m. each day.
