## HERBICIDE

Resicore® REV herbicide is a preplant, pre- and post-emergence, encapsulated herbicide that provides powerful weed control of more than 75 broadleaf weeds and grasses. Resicore REV herbicide offers farmers greater application flexibility on corn up to 24 inches in height and versatility from preplant up to postemergence. Resicore REV also comes equipped with enhanced features, such as increased crop safety, improved handling and tank-mix compatibility, which ultimately leads to greater yield potential.

## Features

- 3 modes of action – acetochlor (Group 15), mesotrione (Group 27), clopyralid (Group 4) – for control of the toughest weeds
- Acetochlor and Clopyralid offer growers a greater level of control on small- and large-seeded broadleaf weeds
- Versatility as preplant, pre- and post-emergence herbicide
- Wider application window post-emergence in corn
- A fit for a wide variety of agronomic programs – conventional, reduced and no-till
- Encapsulated acetochlor for increased crop safety.
- Improved handling and tank-mixing compatibility with key nutrients, such as UAN and Ammonium Thiosulfate
- Tank-mix flexibility with glyphosate, atrazine and other corn herbicides for greater weed control

## Application Recommendations:

**Application Rate:** 1.4 – 3.25 qt/A

### Spray Volume Applications:

Preplant or Preemergence: 10 – 80 gal/A

Postemergence: 10 – 30 gal/A

**Proposed Application Timing:** preplant, pre- and post-emergence (wider application window than current options in the corn herbicide portfolio from Corteva Agriscience).

- Do not apply Resicore REV more than 28 days prior to planting
- An additional 0.25 qt/A may be used in areas of heavy weed infestation
- Do not exceed 3.25 qt/A of Resicore REV per season
- Resicore REV should not be used on soils with greater than 10% organic matter
