RI Business Coalition to Host LIVE Press Conference on Taxation

PROVIDENCE, RI – The Rhode Island Business Coalition, representing trade associations, chambers of commerce and industry organizations, announced today they will be hosting a press conference Monday, June 7th at 11:30 AM. The in-person event will be held at 2000 Plainfield Pike, Cranston, RI and will feature prominent business, industry and political leaders from across Rhode Island who will speak in opposition to proposals to increase taxes on businesses and individuals.

Business groups across the state have spent weeks formally expressing opposition to the proposed tax increases. Recent announcements by the Office of Management and Budget now project a budget surplus in excess of \$550 million, which does not include PPP loan forgiveness or new tax revenues. Further, the numbers do not include the massive \$1.78B in federal stimulus funding Rhode Island has received from the American Rescue Plan Act. This is not the time for the State to raise taxes.

The concerns include proposals to increase taxes on businesses and individuals by adding one new tax bracket for purposes of Rhode Island state income taxation [bills: H5227, H5229 and S.326, S.362, S.370] and a proposal to tax PPP loan forgiveness [HB6121 Article 2- Relating to the Paycheck Protection Program].

Most business owners view the PPP loan as a lifeline to keep people employed throughout the pandemic and pay rent, utilities and benefits. As of now, the majority of states have announced they will not tax businesses for the PPP loan forgiveness; Rhode Island is the only New England state proposing the direct tax on businesses.
