- Categories are Vocalist, Pianist, and Other Instrumentalist. Clubs or districts can submit more than one application in each category.

This is an annual event. Club members in all areas are urged to encourage Young Musicians & Vocalists to enter. This chairman will be pleased to visit your District or Club, offer suggestions and any assistance you may need to participate. Just contact me. Contact schools, music venues in your area and make this competition known to all young musicians!

Awards: A cash award plus certificates recognizing participation will be given to the winning entrant. In each category first prize will be \$500. The finalist in each category may be invited to perform at the state convention or at CFWC board meetings.
