 - 8. Club Delegate or alternate for each twenty (20) or less members; one additional Delegate or Alternate, for each additional ten (10) members or major fraction thereof.
 - 9. Juniorette Clubs one delegate.
 - 10. Affiliate Clubs one delegate.

Bylaws, ARTICLE IX AREAS AND DISTRICTS

SECTION 9.1. Areas

A. For the purpose of electing Federation representatives to certain committees and assuring equality of representation in CFWC, the membership shall be divided into approximately equal membership groups to be known as Areas A, B, C and D.

Bylaws, ARTICLE XIII NOMINATIONS AND ELECTIONS

SECTION 13.3 Area Elections

D. <u>Nominating and Election Committee Members</u>: At the Area meetings in convention in the non-election year of each administration, delegates shall elect from each Area one member and two alternates to the Nominating Committee and one member and two alternates to the Election Committee to serve a one year term. <u>Candidates for the Nominating Committee shall</u> have served one or more terms on the Executive Board.

STEM CELL RESEARCH (Convention 2002, Amended 2007, Amended 2012)

Whereas, Human stem cell research is demonstrating results that will assist victims of diabetes, leukemia, sickle cell anemia, Parkinson's, Alzheimer's, Huntington's, and other diseases or conditions including nerve damage; therefore

RESOLVED, THAT THE CALIFORNIA FEDERATION OF WOMEN'S CLUBS SUPPORT THE CONTINUATION AND EXPANSION OF ADULT STEM CELL RESEARCH BY UTILIZING ONLY BYPRODUCTS (i.e., UMBILICAL CORD AND PLACENTA) OF LIVE AND STILL BIRTHS THAT HAVE BEEN RELEASED AS A RESULT OF INFORMED PARENTAL OR LEGAL GUARDIAN'S CONSENT; and further

RESOLVED, THAT THE CALIFORNIA FEDERATION OF WOMEN'S CLUBS SEEKS TO EDUCATE ITS MEMBERS AT STATE, DISTRICT, AND CLUB LEVELS ABOUT HUMAN STEM CELL RESEARCH.

GREENHOUSE EFFECT (Convention 1989, Substitute Resolution 1994, Reviewed 1999, Amended 2004, Amended 2007, Amended 2012)

Whereas, Sunlight reaching the earth's surface becomes heat that is radiated back to space; and Whereas, The gases in our atmosphere that allow the sun's energy to reach the earth's surface also re-reflect part of the outgoing heat back to the earth, resulting in a natural "greenhouse effect"; and Whereas, Man's consumption of fossil fuels and man's production of methane, chlorofluorocarbons (CFC), and ground-level ozone are changing the chemistry of the atmosphere such that more heat may be reflected and global temperatures may rise significantly; and

Whereas, The United States produces many of the global greenhouse gas emissions, and the transportation sector in the US relies upon petroleum for most of its energy needs, the majority of the petroleum consumed in the US is imported from other countries, and the use of alternative fueled vehicles can significantly

reduce the emissions of greenhouse gases; and

Whereas, Although there is still some uncertainty as to what extent the earth's temperature may rise, the potential environmental threat and risks associated with global warming are potentially very significant to Americans; and

Whereas, The rise in global temperatures may cause changes in rainfall patterns and crop growth, a rise in sea level, beach erosion, decline of fisheries, loss of coastal wetlands, salt water contamination of drinking water, increased power demand for air conditioning, and extinction of species that are incapable of adapting to climate change; therefore

RESOLVED, THAT THE GFWC CALIFORNIA FEDERATION OF WOMEN'S CLUBS URGES GFWC AND THE U.S. GOVERNMENT TO ADOPT POLICIES THAT REQUIRE:

- 1.) IMPLEMENTING ENERGY CONSERVATION MEASURES THROUGH REDUCED ENERGY COSTS; and
- 2.) ADOPTION OF A DATE WHEN THE U.S. WOULD BE CARBON NEUTRAL; and
- 2.) SUPPORTING THE GOAL THAT THE U.S. WOULD BE CARBON NEUTRAL AT 80% BELOW 1990 EMISSION LEVELS BY THE YEAR 2050; and
- 3.) SUPPORTING ANY STATE'S EFFORTS TO SWITCH TO NAUTRAL natural GAS, ALTERNATIVE ENERGY, AND ELECTRIC VEHICLES WHERE THESE CHANGES WILL RESULT IN DECREASED GREENHOUSE GAS EMISSIONS.

CHILD ABUSE AND/OR NEGLECT PREVENTION (Convention 1978, Reaffirmed 1988, 1993, Amended/Reaffirmed 1998, Amended 2003, Amended 2007, Amended 2012)

Whereas, Child abuse includes physical abuse, sexual abuse, psychological abuse, abusive head trauma (Shaken Baby Syndrome); mental/emotional abandonment; and general, medical and educational neglect; and Whereas, Studies show that the abused/neglected child could become a perpetrator on children and/or spouse and that most themselves were abused/neglected children; and

Whereas, This cycle of abuse/neglect must end; therefore

RESOLVED, THAT THE GFWC CALIFORNIA FEDERATION OF WOMEN'S CLUBS URGES THE ATTORNEY GENERAL AND LEGISLATORS OF CALIFORNIA TO INITIATE AND STRENGTHEN CHILD ABUSE/NEGLECT PREVENTION, REPORTING, COUNSELING AND INTERVENTION PROGRAMS; and further

RESOLVED, THAT PROGRAMS SHOULD:

- 1) PROVIDE PROTECTIVE SERVICES ON A 24-HOUR BASIS;
- 2) COUNSEL BOTH VICTIM AND ABUSER;
- 3) CREATE PUBLIC AWARENESS IN SCHOOLS AND IN COMMUNITIES BY EDUCATION ON HOW TO IDENTIFY AND PREVENT THE PROBLEM;
- 4) ENCOURAGE COMPLETE REPORTING AND ACCURATE DATA COLLECTION;
- 5) PROVIDE FOR PROMPT, SENSITIVE ATTENTION BY POLICE, MEDICAL SERVICES, COURTS, AND SOCIAL SERVICES.

EQUAL RIGHTS AMENDMENT (Convention 1969, Reaffirmed 1976, 1987, 1993, Historic 1998, Reactivated and Amended 2012)

Whereas, The General Federation of Women's Clubs has an ongoing interest in as well as an existing resolution supporting continuing action in this area; and

Whereas, The required number of states has not yet ratified the existing proposed Equal Rights Amendment; therefore—A minimum of three states out of the 15 yet to ratify the Equal Rights Amendment must do so in order for it to pass; and

Whereas, Those states are: Alabama, Arizona, Arkansas, Florida, Georgia, Illinois, Louisiana, Mississippi, Missouri, Nevada, North Carolina, Oklahoma, South Carolina, Utah and Virginia; therefore

RESOLVED, THAT THE GFWC CALIFORNIA FEDERATION OF WOMEN'S CLUBS STRONGLY URGES GFWC TO ACTIVELY WORK WITH MEMBER CLUBS IN THOSE 15 STATES TO INCREASE PRESSURE ON THOSE STATE LEGISLATURES TO RATIFY THE EQUAL RIGHTS AMENDMENT; and further RESOLVED, THAT THE GFWC CALIFORNIA FEDERATION OF WOMEN'S CLUBS URGES THAT EFFORTS CONTINUE BY BOTH GFWC AND CONGRESS TO PASS AN EQUAL RIGHTS AMENDMENT THAT WOULD READ IN PART "EQUALITY OF RIGHTS SHALL NOT BE DENIED OR ABRIDGED BY THE UNITED STATES OR BY ANY STATE, ON ACCOUNT OF GENDER."

RELATIONSHIP VIOLENCE AND ABUSED PERSONS (Convention 1996, Amended/Reaffirmed 2001, Amended/Reaffirmed 2006, Amended 2011)

Whereas, Physical, emotional, verbal, psychological, and sexual abuse continues to increase within our society cutting across age, ethnic, racial, educational and socio-economic lines and can cause emotional and behavioral disturbance, physical injury and death to children and adults; and

Whereas, Children who grow up in violent homes are more likely to become batterers or victims themselves than are children from non-violent homes; and

Whereas, The majority of domestic elder abuse perpetrators are family members of the victim, typically serving in a care-giving role, and

Whereas, It is estimated that the incidents of elder abuse are grossly underestimated. For instance, the U.S. Administration on Aging Elder Abuse suggests that only 1 in 14 cases of elder abuse is ever reported; and Whereas, There continues to be a need for emergency shelters and counseling services for all victims of abuse; therefore

RESOLVED, THAT THE CALIFORNIA FEDERATION OF WOMEN'S CLUBS SUPPORT LEGISLATION AND ACTIVELY PROMOTE PROGRAMS WHICH WILL:

- 1. IDENTIFY AT-RISK FAMILIES AND SUSPECTED CASES OF CHILD, SPOUSAL OR ELDER ABUSE
- 2. PROVIDE EMERGENCY AID AND SHELTER FOR THOSE WHO ARE FORCED TO LEAVE VIOLENT FAMILY SETTINGS
- 3. PROVIDE TREATMENT FOR VICTIMS AND REHABILITATION FOR PERPETRATORS OF ABUSE
- 4. PROVIDE PUBLIC AWARENESS EDUCATION PROGRAMS CONCERNING PREVENTION OF ABUSE; and further

RESOLVED, THAT MEMBER CLUBS BE URGED TO ENLIST THE HELP OF HOSPITALS, DOCTORS, HEALTHCARE PROFESSIONALS, LAWYERS, POLICE, SCHOOL PERSONNEL, CHURCHES, COUNSELING SERVICES, SENIOR CITIZEN ASSOCIATIONS, SOCIAL SERVICE AGENCIES AND CLINICS, SHELTERS AND THEIR PROGRAMS IN A UNITED EFFORT FOR PREVENTION AND TREATMENT OF ABUSED PERSONS.

UNITED STATES FLAG AND NATIONAL ANTHEM ETIQUETTE (Convention 1990, Amended/Reaffirmed 1995, Reaffirmed 2000, Reaffirmed 2006, Amended 2011)

Whereas, The Supreme Court of the United States by a 5 to 4 vote, has decided to allow the indiscriminate burning of the flag of the United States of America under the guise of First Amendment rights of free expression; and

Whereas, The decline in values of many Americans has led to a decline in patriotism and appreciation for traditional American beliefs as evidenced by the renditions of the National Anthem and lack of respect during the renewal of the Pledge of Allegiance; and

Whereas, These symbols The U.S. flag and the Star Spangled Banner are recognized worldwide as representative of the United States of America and are loved, respected and revered by the American people who have defended them in war and peace; and

Whereas, The United States Flag Code, Title 36, Chapter 10, United States Code paragraphs 170-178 describe \$5

proper etiquette for both the flag and the anthem; and therefore

Whereas, The members of the California Federation of Women's Clubs are distressed to see this decline in respect for our country's symbols; therefore

RESOLVED, THAT THE GFWC CALIFORNIA FEDERATION OF WOMEN'S CLUBS URGES:

- 1. THAT THE CALIFORNIA SUPERINTENDENT OF PUBLIC INSTRUCTION DIRECT STAFF TO CREATE A TEACHING SYLLABUS TO BE INSTITUTED ANNUALLY IN DISTRIBUTED TO EVERY PUBLIC SCHOOL IN THE STATE OF CALIFORNIA INSTRUCTING ALL STUDENTS IN PROPER NATIONAL ANTHEM AND FLAG ETIQUETTE.
- 2. Whereas, The general population is unaware of the potential threat to their health and safety posed by clandestine laboratories, *which can be located almost anywhere*, such as motel rooms or the trunks of cars where the drug can be "cooked" *using either hot or cold processing methods* by criminals who are often armed and dangerous; therefore

- 2. LABORATORY EQUIPMENT (GLASS TUBES, BEAKERS, BUNSEN BURNERS, FUNNELS),
- 2. CAMP STOVES, HEAT PLATES *OR* PROPANE TANKS, OR COFFEE FILTERS WITH A POWDERY SUBSTANCE:
- 3. EVIDENCE OF LARGE QUANTITIES OF *HOUSEHOLD AND AUTOMOTIVE CHEMICALS*, COLD MEDICATION OR NONPRESCRIPTION WEIGHT-LOSS PRODUCTS,
- 4. PANS, BOTTLES, JARS, THERMOSES AND PAPER OR PAPER FILTERS SHOWING POWDERY CHEMICAL RESIDUE OR HAVING CHEMICAL STAINS, ESPECIALLY THOSE BROWN, WHITE, RED OR PURPLE IN COLOR: further

RESOLVED, THAT CLUBS EDUCATE THEIR MEMBERS AND COMMUNITIES Θ F ABOUT STEPS TO PROTECT THEMSELVES AND OTHERS IF A METHAMPHETAMINE

LABORATORY IS SUSPECTED:

- 1. LEAVE THE AREA AT ONCE,
- 2. REFRAIN FROM INTERFERENCE,
- 3. CONTACT LAW ENFORCEMENT IMMEDIATELY,
- 4. NOTIFY OTHERS WHO MAY BE IN DANGER.

RESPONDING TO THE NEEDS OF VETERANS (Convention 2006, Amended 2011)

Whereas, Over 11% of our population over the age of 18 are civilian veterans; and

Whereas, In the global war on terrorism, non-mortal wounding as of March 10, 2010 total 36,906; and Whereas, As of the end of fiscal year 2010, 437,310 veterans are receiving compensation for Post Traumatic-

Stress Syndrome; and

Whereas, Over 600,000 homeless people are on the streets of America on any given night and 10% to 15% are veterans: and

Whereas, As of 2009, it was estimated that 26, 618 veterans were homeless in California, and

Whereas, Statistics from 2015 show there are 1,693,602 U.S. Military veterans living in California, and Whereas, That Veterans report also showed 2 million out of 21.7 million U.S. veterans are women, and Whereas, It also reported that 28% of veterans are disabled with a variety of physical, mental and emotional disorders, such as amputations and Post Traumatic Stress Syndrome, and

Whereas, In 2014 (most recent statistic) it was estimated that 49,933 veterans living in California were homeless, and

Whereas, The impact on family and community members is not a part of the statistical data that results from returning veterans who are physically, mentally or psychologically impaired, but it is real; therefore RESOLVED, THAT THE GFWC CALIFORNIA FEDERATION OF WOMEN'S CLUBS REQUESTS THAT URGES THEIR MEMBERS TO CONTACT THEIR LOCAL VETERANS ADMINISTRATION AFFAIRS OFFICE AND THEIR LEGISLATORS AT ALL LEVELS OF GOVERNMENT TO URGE PROGRAMS AND LAWS THAT WILL MEET THE CONTINUING NEEDS OF ALL UNITED STATES VETERANS AND THEIR FAMILIES.

The 2016-18 Resolutions Committee moves the following NEW RESOLUTION be passed.

Rationale: the topic is of current concern in the state for the reasons outlined in the text.

015-421 REVIEW OF PROPOSITION 47 (Convention 2017)

Whereas, Proposition 47 was placed on the ballot in November 2014 with the intention of reducing prison and jail populations by reclassifying several nonviolent felonies as misdemeanors and by not incarcerating drug users who committed non-violent crimes; and

Whereas, The voters approved Proposition 47 and it became effective on November 4, 2014; and Whereas, Some areas of the state are now seeing an increase in theft crimes amid concerns that too many former felonies are now being prosecuted as misdemeanors, thereby earning offenders little or no jail time; and Whereas, Savings realized from not incarcerating drug addicts, many of whom pay for their habit through stealing and selling stolen property, were to be directed to rehabilitation programs; and Whereas, 2016 information from the State of California shows that there has been an almost two-year delay in

Whereas, Many California counties in 2016 reported crime statistics showing offenders are returning to the streets to continue to commit crimes and abuse drugs; therefore

RESOLVED, THAT THE GFWC CALIFORNIA FEDERATION OF WOMEN'S CLUBS SEEK TO INFLUENCE STATE LEGISLATORS TO IDENTIFY AND STUDY DATA REGARDING THE RECLASSIFIED CRIMES TO EITHER DETERMINE THE STATUTE CHANGES WERE EFFECTIVE OR THAT THERE IS A NEED TO RETURN CERTAIN OFFENSES TO THE ORIGINAL CLASSIFICATION; and further

RESOLVED, CFWC REQUESTS STATE LEGISLATORS ACCOUNT FOR ALL OF THE FUNDS SAVED FROM PRISON AND JAIL BUDGETS; REPORT TO THE TAXPAYERS THE TRUE DOLLAR AMOUNT; AND SEE TO IT THAT THE FUNDS ARE SPENT IN A TIMELY MANNER ON THE INTENDED PURPOSE OF REHABILITATION PROGRAMS.
