#### **Financial Report**

- Reggie Kapp, Board Treasurer, gave kudos for our new bookkeeper, Mark Arnold Namaste'
  Bookkeeping, for his proficient and quick response to her request for changes to the
  financial reports that he provided to the Board of Trustees. The revised reports included:
  moving the Ministers Compensation from Payroll to (I) Ministers Compensation Wages;
  added the Investment account revenue for September and October to Other Revenue.
- Reggie suggested that we cull down the number of reports (in case Board members felt overwhelmed); specifically suggesting that we don't need the Oct24 vs Oct23 report. Amon commented that he likes this report and Rev. Rafe clarified that these reports are generated by QuickBooks and really aren't extra work for Mark, so all agreed to continue having Mark supply all of the financials he's currently producing for the Board.
