### Stephen Bellum

Stephen, a South Carolina native, and his wife, Carla, moved to Capitol Hill in 2005 after living for nearly a decade in Maine, where they met. A former biomedical researcher, Stephen transitioned to a career in intellectual property law, and opened his own boutique firm. ### Ann Norwood

A native of Greenfield, MA, Ann earned her BA at Vassar College and her MD at the Uniformed Services University (USU) in Bethesda, MD, where she received her Army commission. She met her partner/wife, Jan Moncier, in 1982 while completing her psychiatry residency in San Francisco, CA. Following an assignment to Ft. Hood, TX, Ann and Jan moved to Capitol Hill in 1988 and Ann joined the psychiatry faculty at USU. Her academic focus was on medical education, HIV, trauma, and disasters. Following her Army retirement in 2004, Ann worked at HHS/ASPR, and later the UPMC Center for Biosecurity. Her religious formation developed later in life as her family did not attend church.
