Access READ Act Reports in Illuminate

[Click here](#) to access a list of available READ Act custom reports in Illuminate. These reports help identify students who read below grade level and create targeted intervention plans.

Please note the reports are not based on the READ Act accountability score. Instead, every assessment for each student is loaded. For assessments that have multiple assessment dates (Istation, SRI, STAR), use the "Most Recent Administration" column. This allows teachers to see the most recent test score for each student first, followed by the second, third, etc.

SSPs: Has Your Mid-year Conversation been Scheduled?

Mid-year conversations take place in January and February, when employees provide updates on the services being provided to students and evaluators discuss preliminary ratings, feedback on effectiveness and next steps on how to improve performance. During this conversation, you should:

- Review progress in relation to agreements made in the BoY conversation.
- Review feedback on your performance behaviors in the [SSP framework for professional practice](#).
- Reflect on strengths, growth areas and next steps for your development, and discuss how your supervisor can support growth throughout the year.
- Review observations and data points to ensure they match the agreed upon plan, and finalize plan for next few months.
- Review SLO student growth data.

Conversations are not recorded in Infor HR at mid-year; however, you can use the [SSP Conversation Trackers](#) throughout the year.
