

Whittier Kids Fall Remote Learning All Day Care

Program Hours: 8:15 am – 3 pm

1st-5th graders, Sept. 8-Dec 23

- Students will bring a lunch each day, morning and afternoon snack will be provided.
- Whittier Kids will be open for all regular school days and the first two days of Thanksgiving Break, Nov.23 and 24.
- Whittier Kids will be closed on the following school holidays: October 9, November 11, and November 25-27.
- We are still receiving information from Whittier regarding the structure of the school day so our hours may be modified slightly if required to best support remote learning.
- Unfortunately, we do not have the capacity to offer supportive care to incoming Kindergartners at this time.

Tuition

- Full-Time preference given: \$1250/month, Monday-Friday
- Part-Time if available: \$900/month 3 days/week, \$650/month 2 days/week
- Annual Registration Fee: \$100 (due with September tuition, or at registration if later in the year)
- Billing & Refunds: Parents will be billed monthly and be responsible for the full tuition of registered days— refunds or credits will not be issued for missed days.
- Families will register for the month, much like our regular after school program, with cancellation for the following month due by the 15th.
- In order to keep your children, family, & our staff as safe and healthy as possible, we will prioritize registering students for Monday - Friday so we can keep kids in the same small groups for the month.
- If you don't need care Monday - Friday, submit a request for Part-Time care and we will enroll if we have space available. In this case, the part-time schedule would need to be the same each week for the month and would be charged the 2 day or 3 day/week rates.
- We intend to observe this fee structure through the end of Seattle Public Schools' remote learning period, although changes may be necessary. If SPS moves to a hybrid model of learning, we will re-evaluate.
- We understand these extra child care costs are challenging for families, therefore we are working to apply for grants and funding from external sources. If additional money is procured we will pass those discounts along to families as soon as possible. Remote Learning Support

- Students need to bring their own SPS provided devices and headphones along with meeting ID's passwords, etc. to school each day. We will provide more info as it is available.
- We will do our best to support the remote learning provided by Seattle Public Schools through facilitating a structured learning environment. However, there are many considerations, such as internet bandwidth, electric availability, staff-to-child ratios, etc. that may affect our ability to do so. We are working hard to minimize these as much as possible, including advocating to the district to upgrade the school's Wi-Fi.

Safety

- Groups will be limited to 12 children per classroom and physical distancing will be maintained whenever possible.
- Students and staff are required to wear masks, including during pick up and drop off.
- Staff and children will be required to take a daily health screening upon arrival. Parents will not be coming in the building/classrooms and will need to wear masks during pickup/drop-off.
- Individual art and writing supply kits will be supplied.
- We increased the frequency of when we [clean, sanitize, and disinfect](#) our child care center including cleaning high-touch surfaces throughout the day and a thorough cleaning at the end of each day.
- We reviewed, updated, and are prepared to implement plans for emergencies including an established a process for identifying and sending home children and staff who become sick
- Guidelines are not limited to the above and will be expanded and revised as needed.
